EARLY PUBLIC COMMENT:

Motion was made by HUDSON to open the meeting for public comment; seconded by YAZDI and carried on voice vote all voting AYE. Since there was no one else who wished to speak, GRAZIANO made a motion to close public comment, second by YAZDI & carried on voice vote all members voting AYE, none were opposed.

SPECIAL BUSINESS:

A. COUNCILPERSON VACANCY /APPOINTMENT FOR UNEXPIRED TERM

Pursuant to N.J.S.A. 40A:16-11 the Democratic Committee has submitted three names to the Municipal Clerk

The Municipal Clerk read aloud the names submitted by the Democratic committee via a letter dated December 8th & received December 9th to fill the

vacant council seat of former Councilman John D'Amato who was elected to serve the unexpired Mayor term in 2021 General Election:

- 3. Mark Crum

Motion for appointment of Councilperson

Mayor D'Amato asked for motion to appoint Dominic Catalano to fill the vacant council seat; motion to appoint Dominic Catalano was made by John Graziano, seconded by Dawn Hudson & carried per the following roll call vote: Dellaripa (YES), Graziano (YES), Hudson (YES), Juhlin (ABSTAIN), Yazdi (YES)

Before the Oath of Office was given to Dominic Catalano, Linda Huntley (86 Van Dam Ave, Bloomingdale) inquired as to when the unexpired term of Mayor begins, suggesting January 1st.

It was noted that per N.J.S.A. 40A:16-21 'time for taking office' all persons elected to serve for an unexpired term of an office shall take office immediately upon certification of the election results. In this case, Mayor D'Amato should be sworn in immediately, upon the certification [of the elections] of the County Clerk. (Mayor was sworn into office by the Municipal Clerk on November 24, 2021)

Oath of Office given to Dominic Catalano who was joined with his wife & daughter, by Mayor D'Amato. Followed by a 'welcoming' of Councilman Catalano. Councilman Catalano gave thanks, made brief remarks & joined the council on the dais.

Prior to continuing, Mayor noted the Council will not be entering executive session for the matter of Attorney Client/Privilege ('Meer Tract') as listed on the agenda; there is no update for the council at this point. Future discussion intended for December 28, 2021 Council Meeting.

Councilwoman Hudson added 'congratulations' to Mayor D'Amato & Councilman Catalano. Informed all who were present the County will be hosting a Covid-19 testing site at the Passaic County Community College in Wanaque from 10AM-4PM on December 22, 23, 29, 30th. Booster vaccines also available at local businesses.

DELLARIPA made a motion to open the meeting for late public comment; seconded by YAZDI and carried on voice vote, all in favor voting AYE.

Linda Huntley – 86 Van Dam Ave, Bloomingdale Made the following inquiries:

• [read a statement regarding the Meer Tract/Federal Hill/Tilcon]

Noted the Mayor & Council sent a letter, prepared by the Borough Attorney, to Judge Brogan requesting the court's approval to modify a previously entered order. Noted the modification includes relieving Tilcon of excavation/preparation of 32 acres for affordable housing development, permit unknown developer to build 426 units as opposed to 360 units, reduced sewer/water fees & incentives, & offers a PILOT program. Questioned why this is done behind closed doors without informing or receiving opinions the public & Planning Board.

Ms. Huntley further inquired - if the modification is approved would it be deemed 'court ordered' & would it be known the Mayor & Council requested the modification.

Ms. Huntley further inquired - if the Planning Board does not vote in favor; would the Council override the vote.

In between Ms. Huntley's comments, Mayor D'Amato replied this was not a topic of the special meeting, comments encouraged at the December 28, 2021 regular council meeting. Noted nothing was done behind closed doors. An ordinance was adopted in March. Also noted that during negotiations it was determined Tilcon cannot meet 'site preparation' needs of a potential developer. No further comment was made by Borough Officials.

Linda Shortman – 2 West Shore Road, Bloomingdale Made the following inquiries:

- Inquired as to the date [& minutes] of the council meeting where there was a vote to request [Judge Brogan] make changes
- Inquired as to the date of the letter sent to the judge

Since there was no one else who wished to speak, HUDSON made a motion to close the public comment portion of the meeting, second by YAZDI; all members voting AYE.
