ORDINANCE NO. 1-2021
OF THE GOVERNING BODY
OF THE BOROUGH OF BLOOMINGDALE

AN ORDINANCE OF THE BOROUGH OF BLOOMINGDALE, IN THE COUNTY OF PASSAIC AND STATE OF NEW JERSEY, AMENDING CHAPTER 69 "SITE PLAN REVIEW AND SUBDIVISION OF LAND", ARTICLE V "SITE PLAN DESIGN STANDARDS", SECTION 69-31 "TRAFFIC CIRCULATION", SUBSECTION E "OFF-STREET PARKING AND LOADING AREAS" OF THE CODE OF THE BOROUGH OF BLOOMINGDALE

WHEREAS, the Borough Code currently sets forth requirements and standards for parking and loading spaces throughout the Borough; and

WHEREAS, the Borough Ordinance Review Committee has reviewed the Code and recommended certain changes be made in order to ensure such requirements and standards are consistent;

WHEREAS, the Borough Council has reviewed and accepted the recommended changes as being in the best interest of the Borough.

NOW THEREFORE BE IT ORDAINED, by the Council of the Borough of Bloomingdale, in the County of Passaic, and State of New Jersey, as follows:

SECTION 1. Chapter 69 "Site Plan Review and Subdivision of Land", Article V "Site Plan Design", Section 69-31 "Traffic Circulation", Subsection E "Off-street parking and loading areas" shall be amended to read as follows:

- E. Off-street parking and loading areas.
- (1) The site plan shall provide for sufficient parking and loading spaces to meet the requirements of the Zoning Ordinance, Chapter **92** of the Code.
- (2) An off-street parking area shall be marked off into individual car parking stalls, and each stall shall be not less than nine feet in width and not less than eighteen feet in length (9x18). Aisles shall have a minimum width of 27 feet unless angle parking is permitted, in which case minimum aisle width shall be as approved by the Borough Engineer.
- (3) An off-street truck loading stall shall have a minimum width of 10 feet, a minimum length of 25 feet and a minimum clear height of 14 feet.
- (4) No parking or truck loading stall shall be located within 10 feet of a residential building.
- (5) Entrances and exits and driveways to a parking or truck loading area shall be paved and shall include turning areas and shall be so designed to assure ease of mobility, ample clearance and safety of vehicles and pedestrians. Parking areas shall be paved.
- (6) A parking or truck loading area shall be surfaced with concrete or asphaltic mix and sufficiently drained so as to prevent an accumulation of water on the surface of the areas.
- (7) A parking area shall be illuminated if used after sunset, and such illumination shall provide a minimum of 0.2 footcandle per square foot average throughout the area and be shielded from motorists using the streets or adjoining residential properties.
- (8) Planting strips, consisting of suitable shrubbery or hedges with a minimum height of five feet and a density to shield effectively, the year around, undesirable visual exposure, shall be provided where feasible around hard-surfaced parking or truck loading areas.

(9) Off-street parking and loading areas shall be designed to prevent the maneuvering of vehicles into or out of a parking or loading space within any portion of a driveway that is within the right-of-way line of any street. Off-street parking and loading areas shall be designed so as to avoid the necessity of vehicles backing onto any street from the site.

All other portions of this Section remain unchanged.

SECTION 2. All ordinances or parts of ordinances of the Borough of Bloomingdale inconsistent herewith are repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.

SECTION 4. This law shall take effect immediately upon final passage, approval and publication as required by law.

ORDINANCE NO. 2-2021 OF THE GOVERNING BODY OF THE BOROUGH OF BLOOMINGDALE

AN ORDINANCE OF THE BOROUGH OF BLOOMINGDALE, IN THE COUNTY OF PASSAIC AND STATE OF NEW JERSEY, AMENDING CHAPTER 92 "ZONING", ARTICLE V "REGULATIONS GOVERNING CERTAIN USES", SECTION 92-22 "PARKING, LOADING AND AUTOMOTIVE SERVICES", SUBSECTION A "OFF-STREET PARKING" OF THE CODE OF THE BOROUGH OF BLOOMINGDALE

WHEREAS, the Borough Code currently sets forth requirements and standards for parking and loading spaces throughout the Borough; and

WHEREAS, the Borough Ordinance Review Committee has reviewed the Code and recommended certain changes be made in order to ensure such requirements and standards are consistent;

WHEREAS, the Borough Council has reviewed and accepted the recommended changes as being in the best interest of the Borough.

NOW THEREFORE BE IT ORDAINED, by the Council of the Borough of Bloomingdale, in the County of Passaic, and State of New Jersey, as follows:

SECTION 1. Chapter 92 "Zoning", Article V "Regulations Governing Certain Uses", Section 92-22 "Parking, Loading and Automotive Services", Subsection A "Offstreet parking" shall be amended to read as follows:

- A. Off-street parking. In all districts in connection with every manufacturing, business, institutional, recreational, and residential or any other use, there shall be provided, at the time any building or structure is erected or is enlarged or increased in capacity, off-street parking spaces open to the users at no charge in accordance with the requirements set forth herein.
 - (1) Size and access. Each off-street parking space shall have an area of not less than 162 square feet measuring not less than nine feet in width and not less than eighteen feet in length (9 x 18) in an area exclusive of access drives or aisles, and shall be of usable shape and condition. Except in the case of dwellings, no parking area provided hereunder shall be established for less than three spaces. There shall be adequate provisions for ingress and egress to all parking spaces. The grade of residential driveways shall not be over 15%, and for all other parking areas the grade shall be 10%.

Access to off-street parking areas shall be limited to several well-defined locations, and in no case shall there be permitted unrestricted access along the length of the street or alley upon which the parking area abuts. Permits shall be required for curb cuts except for new residential subdivisions.

- (2) Number of parking spaces required. The number of off-street parking spaces required shall be as set forth in the Schedule of Regulations in accordance with the definition of "floor area" as set forth in Article XI hereof, provided that any residential district, on any lot having an area of one acre or less, private garage space may be provided for not more than five motor vehicles. Space for one additional motor vehicle may be provided for each one-fifth (1/5) acre by which the area of the lot exceeds one acre; and in any residential district, not more than 1/2 of the garage space provided on any lot shall be used for the housing of commercial motor vehicles. In the case of any building structure or premises the use of which is not specifically mentioned herein, the provisions for a use which is so mentioned and to which said use is similar, in the opinion of the Board of Adjustment, shall apply.
- (3) Off-site facilities. All permitted and required accessory off-street parking spaces, open or enclosed, shall be located on the same zone lot as the use to which such spaces are accessory, except that such spaces may be provided elsewhere but shall be provided within a radius of no greater distance than fifteen hundred (1500) feet from that zone lot. For utilization of spaces on property not in the same ownership as the use to which they are accessory, a copy of a lease/license agreement between the user and the property owner allowing the utilization of the spaces must be submitted to the Zoning Officer within 10 days of execution of the agreement. If the agreement is terminated for any reason, the user must immediately notify the Zoning Officer of same and terminate all use.

All other portions of this Section remain unchanged.

SECTION 2. All ordinances or parts of ordinances of the Borough of Bloomingdale inconsistent herewith are repealed to the extent of such inconsistency.

SECTION 3. If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.

SECTION 4. This law shall take effect immediately upon final passage, approval and publication as required by law.

F. Introduction of Ordinance No. 4-2021: Amend Ch. 20 Section 11.5 (*Fees – Road Opening Permits*)

The Municipal Clerk explained the purpose of this ordinance. The first change is to add the words "CASH BOND" into section 20-11.5 (there is a \$200 'cash bond' that residential applicants submit; once their permit is approved by the Engineer; the money is reimbursed to the applicant) this is being done to provide clarity and give clear direction for the Finance department to return the funds to the resident.

Under the same subsection, letter B. the current code reads that Utility companies (PSE&G) must provide a \$2,000 bond when they apply for a road opening permit. Per the Borough Engineer, if the work is ever unsatisfactory – the \$2,000 would not be enough to fix a patch should a utility company fail to repair. We are changing this to \$10,000.

The last change is reinstating sections that were deleted in error.
