#### RESOLUTION NO. 2020-5.2 OF THE GOVERNING BODY OF THE BOROUGH OF BLOOMINGDALE

RESOLUTION OF THE BOROUGH OF BLOOMINGDALE, COUNTY OF PASSAIC, STATE OF NEW JERSEY, INSTITUTING A GRACE PERIOD THROUGH JUNE 1, 2020 FOR PAYMENT OF SECOND-QUARTER PROPERTY TAXES DUE MAY 1, 2020 PURSUANT TO EXECUTIVE ORDER 130

**WHEREAS**, pursuant to N.J.S.A. 54:4-66(a), second-quarter property taxes in the Brough of Bloomingdale are due May 1, 2020; and

**WHEREAS,** on April 28, 2020, in response to New Jersey's ongoing COVID-19 Public Health Emergency and State of Emergency, Governor Philip D. Murphy issued Executive Order No. 130, which authorizes municipalities to institute by a grace period concluding on a date no later than June 1, 2020 for the payment of second-quarter property taxes due May 1, 2020; and

**WHEREAS**, the Mayor and Council of the Borough of Bloomingdale, County of Passaic, State of New Jersey, due to the economic impact of COVID-19, desire to provide relief to the residents of the Borough by providing an extension to the state mandated grace period, whereby an interest penalty on payments made after May 11, 2020 would normally have been charged; and

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Bloomingdale, in the County of Passaic and State of New Jersey, as follows:

- 1. In accordance with Executive Order 130, the Borough of Bloomingdale hereby institutes a grace period through June 1, 2020 for the payment of second-quarter property taxes.
- 2. In the event taxes are not paid by June 1, 2020, the Borough is obligated to assess applicable interest and penalties as set forth by law.
- 3. The Municipal Clerk shall notify the Director of the Division of Local Government Services in the Department of Community Affairs of this Resolution no later than the third business day following its adoption.

The motion was second by D'AMATO and carried on voice vote, all members voting AYE, none were opposed.

#### LATE PUBLIC COMMENT

D'AMATO opened the meeting to late public comment; seconded by SONDERMEYER and carried on voice vote. Since there was no one who wished to speak HUDSON moved that it be closed; second by DELLARIPA and carried on voice vote all members voting (AYE).
