Councilwoman Shortman stated that she cannot vote on this until she speaks with the Board of Education as to their feeling on the PILOT program. She stated this is a huge issue and needs to be very carefully thought out. She will attend the Board of Education meeting next Monday to get their opinion on this. She also stated she has not seen the Financial Agreement which is part of this ordinance and wants to look at that first.

Discussion as to legally encumbering the Governing Body to use these funds to pay down the debt; Councilman Yazdi stated that if the ordinance is adopted, he will make a motion to draft an ordinance in that respect.

Councilman Yazdi moved that the second and final reading on Ordinance #16-2012 be carried to the September 18, 2012 meeting at 7:30 p.m. and all comments which we heard this evening will be considered the Public Hearing on this ordinance; seconded by Councilman D'Amato and carried as per the following roll call: Council Members: D'Amato; Shortman and Yazdi all YES. ABSENT: Council Members: Conklin; Pituch and Schiffman (Excused)
