PRESENTATION TO SALVATION ARMY

Councilwoman Pituch also asked about a repair for a truck, Item #01482 which was not brought to the Council and asked to be informed the next time.

Councilwoman Pituch also asked why former Councilman Crum's salary is only being paid now; Borough Administrator stated that he doesn't know why the paperwork is being processed this year and not last.

Discussion followed in regard to repair of vehicles and Councilman Specchio felt we should get some estimates for a new truck.

Approval of Contract for Shared Services Agreement with Washington Township <u>for Email Server</u>

Councilman Marinaro moved to approve a Shared Services Agreement with Washington Township for Email Server; seconded by councilman Vroom.

Councilwoman Huntley felt we should con tact other communities to see how they are handling their emails; Councilwoman Pituch asked how the County handles their emails.

Borough Administrator noted this would be a shared service that Bloomingdale would use Washington Township's server; they are the host town.

Discussion followed as to fact that this is the first shared service of this type and there is 90 day opt out clause. Councilwoman Huntley wanted clarification on the flowing rate and what other towns do; Borough Administrator will check into and report back at next meeting.

Councilman Marinaro with drew his motion and Councilman Vroom withdrew his motion. This will be on the next work session.

Update as to BASS Contract

Noted that there are two more letters complaining as to the BASS shelter that have come in.

Discussion followed as to the dumpster which was at BASS and is no longer useful; cost to replace ranges from \$700 to \$1,000. Borough Administrator asked the Mayor and Council if they wanted to purchase a dumpster for BASS and take the cost off of the \$14,000 once we pay them.

Councilman Schiffman stated that they should purchase a dumpster themselves.

Acceptance of resignation of Daniel Tuzzio as Mayor's Representative on Library Board of <u>Trustees and appointment of Cathy J. Gurbisz to replace him</u>

Councilman Schiff moved to accept with regret the resignation of Daniel Tuzzio as Mayor's Representative on Library Board of Trustees and appointment of Cathy J. Gurbisz to replace him for an unexpired term; term expiring December 31, 2010; seconded by Councilman Schiffman and carried on voice vote.

Discussion as to purchase, condition and maintenance of Borough vehicles

At this time, Borough Administrator went over the list of vehicles that need to be repaired and/or replaced.

Councilman Schiffman discussed fact that when he went to the Department of Public Works to look at our vehicles he found out that the plow on the one of the trucks was damaged and was upset that we did not know about this beforehand and concerned that we are coming up on snow season and have no plow. We need some estimates as to how much it will be to fix it.

Discussion followed; Borough Administrator stated that the Ad Hoc Committee which was formed was going to review the vehicles and make repairs; vehicles that were proposed in the budget were removed.

This will be discussed at the next meeting.

Adoption of Resolution #2010-10.15: Rescinding Resolution #2010-9.15

Borough Attorney stated that this is a housekeeping item and the resolution #2010-9.15 which was passed at the September 28, 2010 meeting was not needed due to the fact that the budget was subsequently adopted.

Councilman Marinaro offered the following Resolution and moved for its adoption:

RESOLVED, that Resolution #2010-9.15: Temporary Emergency Resolution which was adopted at the September 28, 2010 meeting be RESCINDED due to the fact that subsequently at the same meeting the 2010 Municipal Budget was adopted negating the need for this Resolution.

Councilman Schiffman seconded the motion and it carried as per the following roll call: Council Members: Pituch; Schiffman; Specchio; Vroom; Huntley and Marinaro all Yes.

RECESS

The Mayor and Council Recessed at this time, 8:45 p.m.

RECONVENED

Mayor Steenstra reconvened the meeting at 9:04 p.m.

LATE PUBLIC COMMENT

Councilman Vroom opened the meeting to late public comment; seconded by Councilwoman Pituch and carried on voice vote.

Edward Ball, 13 Crane Avenue, spoke in regard to the money which the homeowners pay for meters; where does that go; shouldn't that offset the cost. He asked how much the hydrants cost to put in and does our Water/Sewer Department do all the work.

Borough Administrator stated that most of them, we have to have subcontracts do the work.

Mr. Ball felt the cost of \$30,000 quoted by the Administrator to repair the salt truck was high and suggested he get quote from Tony Sanchez Limited in Ledgewood.

Mr. Ball also stated that the Committee only had one meeting with the DPW Superintendent and we did not review the trucks outside; plow was not brought up.

Mr. Ball spoke of a letter he received from property Maintenance/Code Enforcement about bagging leaves; there was no date on the letter and not addressed to him. Noted that he tried to call the number on the letter but it didn't say anything as to who he was calling; he also stated that he has been complaining about 26 Crane Avenue for years and nothing has been done about that.

Borough Administrator will check into the notice and give Mr. Ball a call.

Mr. Ball also asked when the lights on Main Street will be fixed; Borough Administrator stated t hat we had to first find out who damaged them, submit to our insurance carrier, wait for reimbursement which we have received and now he has to go out for quotes to fix the mounts.

Jon Dunleavy, 51 Morse lakes Road, spoke in regard to fact that the Water/Sewer Superintendent attended the last meeting and asked for \$75,000 and noted that he would not have asked for that amount if he didn't think we needed it and stated the process should go forward.

Mr. Dunleavy spoke in regard to the DelGuidice lawsuit and asked about the cost of legal fees to the Borough due to the intervener's lawsuit.

Borough Attorney stated that they are paying their own lawyer.

In regard to the email server, Mr. Dunleavy stated that it was discussed prior to this evening and noted that this should be "hashed" out before a meeting; is there a contract or not.

In regard to the money due BASS, the \$14,000 payment was on the last bill list and they were told they would receive it.

In regard to the maintenance of vehicles, it was noted that the committee is waiting for a report per Councilman Schiffman.

Mr. Dunleavy asked what the function of the committee is and it was noted they are an ad hoc committee and their job is to make recommendations to the Mayor and Council in regard to maintenance and purchasing of vehicles.

Mr. Dunleavy stated the Superintendent should let the Committee know; discussion in regard to maintenance logs and it was noted that the Borough Administrator will have a report by the next meeting.

Borough Administrator stated that he was instructed to wait on the van until the budget was in place.

Leslie Monsees, 153 Rafkind Road, asked what the cost is to go out for bonding; what is our bonding capacity. Mrs. Monsees also stated she was surprised the vehicles were not in the budget.

Borough Administrator stated that the police vehicle was withdrawn and money was left in for the fit up. DPW truck and salt truck repair were discussed and there is repair money in the budget.

In response to legal fees for DelGuidice, borough Attorney stated that it was in defense of a decision made by the Planning Board.

Linda Shortman, W. Shore Road, spoke in regard to prior appeals by the Board and there were legal defense costs involved, i.e. Patriot Ridge.

Mrs. Shortman spoke in regard to property maintenance in the Borough and asked what the hours of the property maintenance officer are; Borough Administrator will have him attend a meeting.

Borough Administrator stated that as he has informed Mrs. Shortman before, the Police Department is the enforcing agent for garbage left out.

Since there was no one else who wished to speak under Late Public Comment, Councilman Schiffman moved that it be closed; seconded by Councilman Specchio and carried on voice vote.
