Executive Summary

Annually, Passaic County must review and report its progress in carrying out its Five-Year strategic plan and the Annual Action Plan.

During FY 2020, Passaic County received \$914,302 in CDBG funding. Funds were allocated to public facility improvements, street improvements, handicap barrier removal projects, water and sanitary sewer improvements, public services and administration as shown below.

The design and bidding of many of the FY 2020 projects were completed with work initiated in FY 2020.

Additionally, work continued on grant activities through COVID funds. In total the county received three covid allocations, CDBG 1 and 3 from HUD and CDBG CV 2 from NJ DCA. CV 2 funds were allocated and awarded in FY 2020 to 9 agencies while CV 3 funds will be used to support the county's emergency rental assistance program - Impact Passaic.

The County continued to use funds to address the high priority needs for infrastructure and facility improvements as identified in the Five-Year Plan. CDBG funds have been directed to the twelve participating jurisdictions in the Urban County. The highest priority, infrastructure needs in lower income neighborhoods, were addressed through the use of CDBG funds.

This is the third report of the Five-Year period 2018-2023. This report captures data from projects that were initially funded in prior years 2017 and 2018. Many projects take more than one year to complete.

Narrative

The table above shows the 2020 grant amount for CDBG as well as the CDBGCV1 and 3 allocations to Passaic County from HUD. The funds were expended as shown in PR26 and PR03 and described in the Executive Summary.

Additional resources available to Passaic County in FY 2020 include a CV 2 allocation from DCA of \$2,287,345; public housing agency funds for the Section 8 program; and, McKinney Vento Continuum of Care (CoC) funds. CoC grant awards for FY 2020 were made to Passaic County for \$4,411,971 for renewal projects and a new supportive Housing Services to be provided by St. Joseph's Hospital and Medical Center.

Passaic County is part of the North Jersey Sustainable Communities Consortium. In November 2011, HUD notified the Consortium that its application had been selected for an award in the amount of \$5 million. Through participation in this program, the region expects to address broad livability and sustainability goals for housing, economic development and transportation.

The CDBG Program tends to be highly leveraged with local funds in Passaic County. Communities bond for the project costs. Local assets used to leverage CDBG funds include the following public facilities that were improved:

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

A new COC grant for 10 Supportive housing units was awarded to St. Joseph's through the 2020 competitive. These units were made available in 2021.

The Housing Agency was also selected by the Department of Housing and Urban Development to receive 29 Emergency Housing Vouchers through the American Rescue Plan Act. Seventy thousand of these vouchers were distributed on July 1, 2021 to housing authorities based on geographical need and the authority's previous ability to lease up families in their existing programs. These vouchers are targeted to assist individuals or families that are homeless, at risk of homelessness, fleeing or attempting to flee domestic violence, dating violence, sexual assault, stalking, or human trafficking, or were recently homeless and have a high risk of housing instability. Any applicants for this program must be referred to

the Housing Agency by the County Department of Human Services. The Housing Agency has already issued 25 of the vouchers and 2 of them have been leased up in units. In order the assist the families into transitioning into a new apartment, HUD has also supplied service fees which may be used for security deposits, realty fees, utility bills, and the purchase of household items if needed.

Discuss how these outcomes will impact future annual action plans.

The County will endeavor to identify and support affordable housing programs and the CoC in the creation of housing for persons who are experiencing homelessness. CDBG projects may or may not be funded with the limited CDBG funding available to the County however.

With our CDBG funds we have not undertaken housing activities nor services directed to the homeless or persons with special needs through CDBG funding. CDBG CV funds, however, were directed to both housing for the homeless and a special needs housing project to protect residents from the spread of Covid.

To address worse case needs and those of persons with disabilities, the County has taken the lead with the County-wide CoC and provided support over many years. The County administers HUD SHP grants to several non-profits providing dozens of permanent supportive housing units. These units provide housing for chronic homeless individuals and families. By definition these persons are disabled and homeless.

The County does not have a HOME Program. CASA and Home Care Options clients are presumed benefit. There were no activities with income intake.

CR-25 - Homeless and Other Special Needs 91.220(d, e); 91.320(d, e); 91.520(c)

The Passaic County Continuum of Care (CoC) is supported by the staff of the Department of Human Services and administered by the Passaic County Interagency Council on Homelessness. The Passaic County community development goals are set based on the work of the CoC in setting policies and implementing programs to prevent homelessness and assist persons who are homeless.

Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

NJ 2-1-1 provides a point of access for shelter and emergency services. When someone calls 2-1-1 for shelter placement, diversion and eligibility screening is conducted to streamline access. Further, the CoC maintains a coordinated assessment and prioritization list to place individuals in permanent supportive housing.

During the year, provider agencies regularly provided outreach to homeless individuals living on the street and to those at risk of becoming homeless. The PATH Program provides regular outreach at known locations. Further, through partnership with the eviction courts, PATH has addressed the needs of those at-risk of losing their housing. When families are removed from the welfare list, outreach is conducted to see if they have short-term places to live and long-term plans for permanent housing. Additional street outreach is conducted by "They Have A Name" to encourage people to move to shelter and services.

The SSVF and Community Hope coordinate street outreach to homeless veterans.

Due to Covid, the County has initiated testing and the use of hotel/motel residences to deconcentrate the shelters and prevent the spread of the virus.

Addressing the emergency shelter and transitional housing needs of homeless persons

Passaic County has 379 shelter beds of which 34 are transitional housing beds (HIC January 2020). The PCICH works with all the shelters in the County to ensure capacity to meet emergency needs. All the shelters and transitional housing facilities participate in the Point-in-Time count and provide client level information to the Housing Prioritization List to connect their clients to permanent housing opportunities as quickly as possible, as described above. In addition, NJ-211 provides a streamlined hotline for accessing emergency shelter and transitional housing programs, reducing the need for clients to contact each emergency shelter or transitional housing program directly.

The Passaic County Homeless Trust Fund has also funded rapid re-housing and services in support of rapid re-housing projects.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

Catholic Family and Community Services is one of the larger service providers in Passaic County. As noted in the City of Paterson CAPER, CFCS works with the local hospitals when discharging patients. Services are provided through 2-1-1 and hotel vouchers are used to provide housing.

More needs to be done to address youth leaving foster care and other youth facilities. Although funding is available through the County to provide housing up to age 25, many youth simply want to leave the system. Youth homelessness is a focus for study in the coming years by the COC. This was one of the points raised in the most recent needs assessment completed for the COC.

The State of New Jersey's psychiatric hospitals follow state guidelines that prohibit the discharge of patients into homelessness. All persons must have housing secured upon release or they remain in the hospital system until it is secured. The privately funded mental health residential programs are either state funded and abide by the protocols or choose to do so voluntarily.

Correctional facilities in Passaic County have established protocols for discharge. Social work staff coordinates with County Board of Social Services housing placement upon an individuals' release. There is a Re-Entry Policy Academy which focuses on ex-offenders re-entering communities. Upon discharge, Project PRIDE helps individuals to access mainstream resources benefits from Passaic County Board of Social Services. To ensure appropriate supportive services upon discharge, an individualized discharge plan with referrals to appropriate community agencies is created. In addition, a life skills class is offered to eligible recipients to ensure integration into the community. The first 60 days of the class take place in jail and the last 30 days take place at the Passaic County Board of Social Services after release from jail. A meeting of various County agency representatives (mental health, DHS, workforce) and the PREP (Passaic County Re-Entry Program) members (social workers at the Passaic County jail) is held to discuss and strengthen the coordination for discharges from jails.

Passaic County does not receive Emergency Solutions Grant funds, however the City of Paterson does. The ESG funds are granted to Catholic Family & Community Services Center to provide prevention services to 150 extremely low- to very low-income households facing homelessness. No direct rent assistance is provided through the federal grant programs. The funds provided services to over 175 households in 2020.

The Passaic County Homeless Trust Fund provided a grant of \$34,000 to NJ 2-1-1 to operate a homeless hotline. Persons who are in imminent threat of losing their homes are referred to the County Board of

Social Services. With the new Treasury funds being released for rent assistance for households impacted by COVID, the County will start to address homeless prevention on a large scale, \$36 million.

The County administers the Division of Weatherization and Home Energy whose objective is to reduce the home energy burden for eligible low-income families and individuals in Passaic County to avoid homelessness. Passaic County assists low-income individuals and families through Home Energy benefits that reduce clients' energy bills and by implementing weatherization measures that reduce households' energy consumption.

The Low-Income Home Energy Assistance Program; and the Universal Services Fund provides grants to low-income individuals to pay their PSE&G bills. These funds help to keep low-income individuals and families in their homes and help them to not become homeless. In addition, the County offers a Weatherization Program funded through the Low-Income Energy Assistance Program grant; US Department of Energy grant; and the Heating Improvement Program grant. These grants help low-income individuals and families remain in their homes by repairing or replacing windows, doors, insulation, boilers, furnaces and hot water heaters. In total, the County received \$2,555,400 in grants and 12,319 low-income individuals and families were assisted County-wide.

Coordinated referral and an extensive inventory of services provide an opportunity for persons who are homeless to make a successful transition to permanent housing. The CoC Priorities are: (1) ending chronic and veteran homelessness, (2) creating new low-barrier housing first-oriented permanent supportive housing and rapid re-housing projects, and (3) creating a systemic response to homelessness through coordinated entry and assessment

- To end chronic homelessness, the CoC is utilizing a Housing Prioritization Tool to prioritize chronically homeless persons for permanent supportive housing opportunities systematically and is supporting projects that have low-barrier intake and termination criteria, this includes having had NJCDC sponsor 15 new Housing First vouchers for the chronically homeless utilizing State Rental Assistance from NJ DCA

- To create a systemic response to homelessness, the CoC has funded NJ 2-1-1 to cover the full geographic area with Coordinated Assessment access, and is holding case conferencing conversations among CoC-funded and emergency shelter providers to prioritize resources for those who are longest time homeless and with the greatest severity of service needs.

Preventing homelessness

Coordinated referral and an extensive inventory of services provide an opportunity for persons who are homeless to make a successful transition to permanent housing. Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The Passaic County Coordinated Assessment System prioritizes homeless persons and meets monthly to fill vacancies and house those on the list. The length of time someone is on the list is tracked. Further, the CoC is working with agencies to more quickly move persons who are homeless and living in shelters or transitional housing to permanent housing.

Through partnerships with the Children's Inter-Agency Coordinating Council (CIACC), education system partners, homeless liaisons, the behavioral health care system, child protective services and the homeless services system, homeless students and their families are identified and service plans developed to meet their needs. CIACC offers cross-training on homeless definitions, compliance and requirements, support systems for the homeless and effective community service providers. CIACC has developed a standardized intervention model for use in school settings to effectively determine the service needs of homeless children and connect them to appropriate providers.

The Passaic County Department of Human Services has hired a full-time veteran's services staff member to coordinate the goal of ending homelessness for veterans. Veteran Affairs Supportive Housing (VASH)

staff members are active in the CoC and its sub-committees. This coordination has resulted in assistance to veterans in securing and maintaining housing. The veteran's subcommittee of the CoC, led by the local SSVF providers, has also created a by-name list for homeless veterans in the CoC, ensuring they are connected to permanent housing as quickly as possible.

The PCICH is working to shorten the length of time persons are homeless by creating more permanent housing and rapid rehousing programs to quickly move clients into permanent housing. Through the coordinated assessment committee, the most vulnerable clients are targeted for housing opportunities including permanent supportive housing and rapid rehousing vouchers. In FY2016, the CoC was awarded 7 new units of rapid rehousing for homeless families and individuals through Heart of Hannah. In the recent FY2020 CoC competition, the CoC submitted two new applications for permanent housing through St. Joseph's Hospital (10 units of permanent supportive housing for the chronically homeless) and Advance Housing (4 units of rapid rehousing for Domestic Violence Households) for a total of 14 new units.

Reducing returns to homelessness is also being addressed by placing a priority on job training and services for persons who are homeless and in rapid rehousing and permanent housing programs. Recently, there was a training held by the Director of the Workforce Development Board on how to connect CoC clients to jobs and training opportunities.

The County budgeted \$15,000 in FY2020 CDBG funds for the County Court Appointed Special Advocates (CASA) program which assists foster youth make the transition to permanent housing and independent living. An additional \$120,000 through CDBGCV1 funds to assist children in foster care through the Neighborhood Assistance Program has been allocated. This program will provide essential supplies to 800 CASA children and caregivers who must socially distance and/or quarantine. Food, diapers, formula, baby wipes, and PPE - face coverings, gloves, hand sanitizers and cleaning products. 50 volunteers donating 900+ hours. CASA will also develop a software system to track needed supplies from donated supplies and supplies that must be purchased. This includes software and hardware. Acquisition of PPE supplies, including masks, gloves, sanitizers for children and caregivers and volunteers to prevent the spread of COVID-19 will also be provided. The Community Relations Director will devote 20 hours per week toward the implementation of the program.

CR-30 - Public Housing 91.220(h); 91.320(j)

Actions taken to address the needs of public housing

There are no public housing units in the Urban County.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

Passaic County has a Public Housing Agency which administers 835 Section 8 Housing Choice Vouchers. There are no public housing units within this Agency. The jurisdiction of the Agency includes all of the municipalities in the County with the exception of Passaic, Paterson and Clifton as these towns have their own Housing Authorities.

The Agency administers a Family Self Sufficiency program which has a minimum of 70 to 75 families participating each month. The families are constantly recruited from the pool of tenants that are currently being assisted with rental subsidy. The Program is a five-year plan in which families work towards achieving goals that will enable them to become economically self-sufficient. The Agency partners with local entities that provide job training, interview techniques, clothes for employment, and other workshops which encompass a variety of topics from esteem building to financial planning. During the course of the five-year program, if the family's income increases and rental subsidy decreases, the difference is put into an escrow account for the family. The family receives the amount saved providing that they reach their goal during the five-year period and they have been working for the last 12 months.

As of November 1, 2020 the Housing Choice Voucher Family Self Sufficiency Program has had 5 graduates for the current fiscal year. The graduates received a total of \$89,708.45 in escrow monies. One graduate became self-sufficient and is no longer on rental subsidy. Another graduate completed a bachelor's degree in Psychology and others completed CNA and medical billing programs. The graduates are all gainfully employed in professions which were part of their individual goals.

The Housing Agency was also selected by the Department of Housing and Urban Development to receive 29 Emergency Housing Vouchers through the American Rescue Plan Act. Seventy thousand of these vouchers were distributed on July 1, 2021 to housing authorities based on geographical need and the authority's previous ability to lease up families in their existing programs. These vouchers are targeted to assist individuals or families that are homeless, at risk of homelessness, fleeing or attempting to flee domestic violence, dating violence, sexual assault, stalking, or human trafficking, or were recently homeless and have a high risk of housing instability. Any applicants for this program must be referred to the Housing Agency by the County Department of Human Services. The Housing Agency has already issued 25 of the vouchers and 2 of them have been leased up in units. In order the assist the families into transitioning into a new apartment, HUD has also supplied service fees which may be used for security deposits, realty fees, utility bills, and the purchase of household items if needed.

Actions taken to provide assistance to troubled PHAs

The Passaic County Housing Agency is not designated as troubled.

CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

Passaic County does not have jurisdiction over land use controls in compliance with the Municipal Land use Law of the State of New Jersey. Building codes are also governed by state law and implemented by each municipality. There are no County policies identified that have a negative impact on affordable housing.

Over 51% of the County has been designated as the Highlands Region by the State of New Jersy. This designation substantially reduces or eliminates development and effectively eliminates the ability to create new affordable housing opportunities. In addition, these areas have limited water and sewer infrastructure and this also reduces the ability to construct new affordable housing units.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

CDBG funds were not used for housing development nor homeless services in FY 2020. The County uses its Homeless Trust Fund to provide assistance to agencies that address homelessness in Passaic County. CDBG funds were used to provide services to the elderly who have limited mobility and transportation options. Through CDBG funding, Home Care Options provides services to homebound seniors to assist with shopping and doctor's visits. This service allows many older adults to remain in their homes rather than have to move to assisted living. Home Care Options served 172 adults.

CASA, also funded by the Passaic County CDBG grant, serves youth who are removed from their families and become wards of the state. As advocates they act in the child's best interest and ensure that the children are receiving the services they need such as safe housing; attend school; and receive medical services. CASA assisted 10 children.

Other county offices such as the Human Services Department address homelessness and provides motel vouchers for overnight shelter, food and transportation vouchers and other immediate needs. The Passaic County Homeless Trust Fund provided a grant of \$34,000 to NJ 2-1-1 to operate a homeless hotline and the development of coordinated entry services. Additionally, \$120,000 was awarded to NJCDC for case management services for individuals in supportive housing with mental health and substance use treatment and case management needs.

The County provided emergency food to homeless persons: 338,995 meals to 33,826 individuals and 52,806 people in families. The county provided shelter to 369 individuals and 167 families and provided 127 hotel vouchers. 3,306 units of case management for 58 individuals and 394 people in families were provided and 245 rent vouchers were provided for 44 individuals and 499 people in families. 59 utility vouchers were provided for 9 individuals and 162 people in families. 23 vouchers for security deposits were provided for 10 individuals and 47 people in families.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

Passaic County Department of Health addresses lead-based paint in the Borough of Woodland Park only. Other communities in the county each have their own Department of Health and are responsible for assessing the needs of children that present with elevated blood lead levels. Building code departments throughout the County are responsible for enforcing state law prohibiting the use, and addressing the presence, of lead-based paint through their permitting process.

The Health Departments are keenly aware of the problems of lead-based paint. When lead paint has been identified in a unit constructed prior to January 1, 1978, only an EPA qualified contractor performs lead hazard reduction activities. New Jersey laws provide that a contractor must employ a certified lead-based paint abatement supervisor, or have employees certified in lead-based paint abatement. Certified testing companies perform a pre-rehabilitation risk assessment for lead-based paint hazards and a post-rehabilitation clearance test for lead dust hazards where the non-emergency work disturbs a painted surface.

The State of New Jersey offers Lead-based paint remediation through the Lead-Safe Remediation Pilot Program. Lower income households (both renter and owner) can qualify for assistance from the Department of Community Affairs.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

Through implementation of many programs outside of the CDBG program, Passaic County works with families to reduce the number of families with incomes below the poverty level. The Workforce Development Board (job training, apprenticeships and youth training) and the One-Stop Career Center create new job opportunities and offer training programs. Through educational opportunities small and medium sized business owners are provided with resources to expand their businesses, hire new workers, and take advantage of training and employee development programs.

Additionally, the County, in conjunction with the public and private agencies and institutions, provides low-income households with the opportunity to gain the knowledge and skills to become fully self-sufficient. The agencies participating in the Continuum of Care encourage job training and employment for those facing homelessness. Life skills counseling, drug and alcohol counseling and mentoring service provide a means to becoming employable.

During FY 2019, the Passaic County Department of Human Services completed a study on the Needs of Individuals and Families in Passaic County, New Jersey: Community Mobilization for Collective Impact. This study identified community needs and trends and has made recommendations for strategies that would be transformative in how government assistance addresses the needs of the community and the individual.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The County Department of Planning and Economic Development is responsible for the administration of the CDBG program. All sub-recipient agreements are monitored on an ongoing basis. The County participates with other groups where appropriate, as it does in planning for the homeless, to facilitate cooperative problem solving in Passaic County.

The current institutional structure provides a solid foundation for grant administration and maximize the level of assistance that reaches the community.

The CoC is continually working to enhance its organizational strengths. The County has implemented a coordinated entry list in the Homeless Management Information System (HMIS) which is managed by NJ 2-1-1. All new applicants are entered into this system and referrals to open permanent housing slots are taken from this list. We are initiating efforts to enroll each warming center placement into HMIS for assessment for coordinated entry during Code Blue conditions.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

The County continued efforts to enhance coordination between agencies by creating partnerships in the implementation of the Section 3 outreach initiative and the Passaic County Interagency Council on Homelessness. The Section 3 outreach effort will partner with the Passaic County Workforce Development Center and the agencies involved in the Human Services Advisory Board to identify Section 3 individuals and businesses and to provide feedback on available job opportunities. The Passaic County Interagency Council that administers the Continuum of Care is comprised of providers of homeless services and prepares the McKinney application for funding from HUD.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

Passaic County completed an Analysis of Impediments to Fair Housing Choice (AI) in 2018 which was sent to HUD in September. The AI identifies barriers to fair housing and outlines action steps to address these impediments.

Barriers include:

1. County Impediments

- Impediment A: Limited housing choice results in Housing Choice Vouchers concentrated in primarily older, less expensive communities
- Impediment B: Public transit limits mobility and housing choice
- Impediment C: The Land Use and Housing Elements of the Comprehensive Plan require updating
- Impediment D: Planning documents in some municipalities are not in alignment with fair housing laws

2. Private Sector impediments

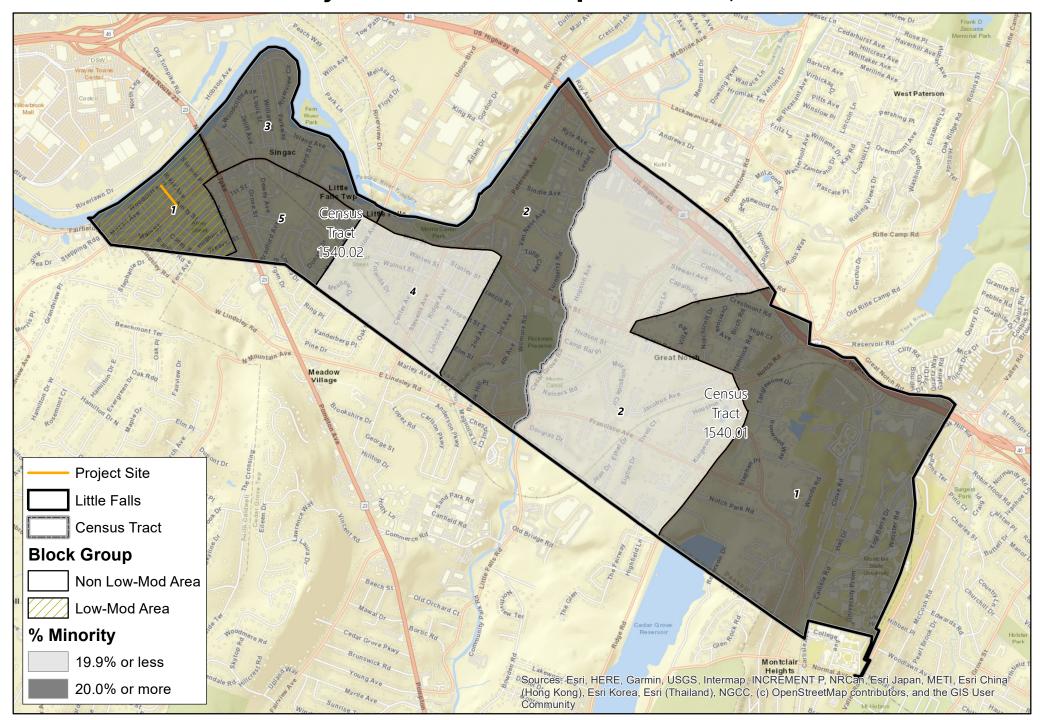
- Impediment A: Non-White households are less likely to be homeowners and are more likely to have been offered a high-cost loan than White households
- Impediment B: Newspaper advertising does not consistently include the fair housing logo
- Impediment C: Members of non-White households face lower wages and higher unemployment rates which de facto limits housing choice

During FY 2020, Passaic County continued to be stymied on hosting a Fair Housing Seminar due to COVID-19.

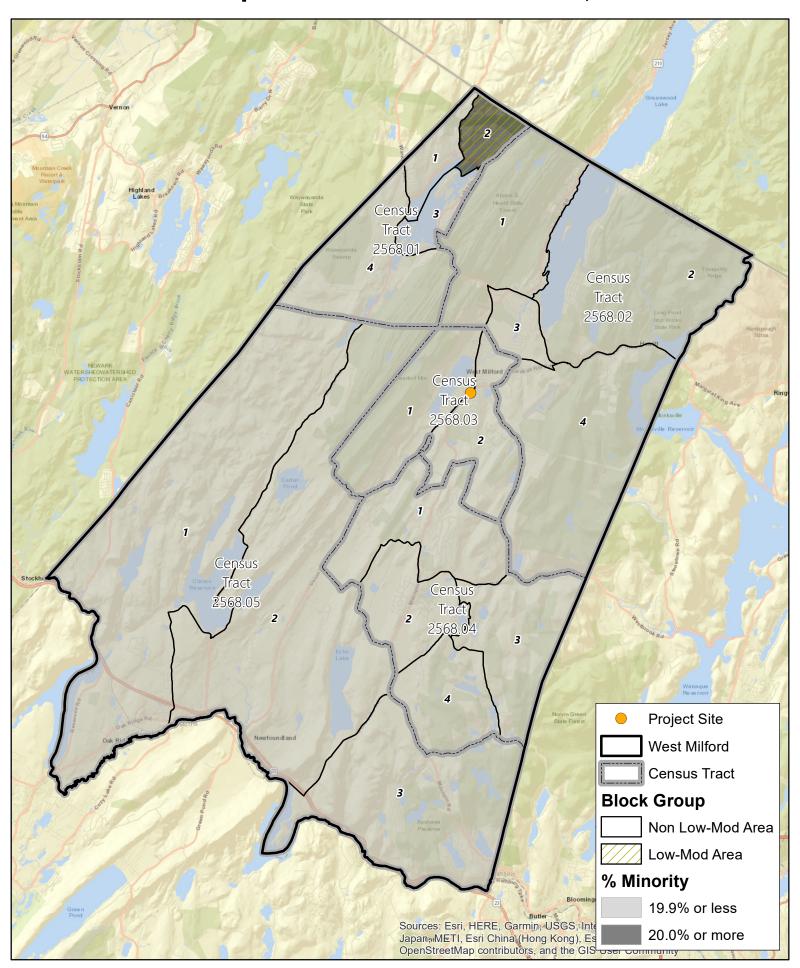

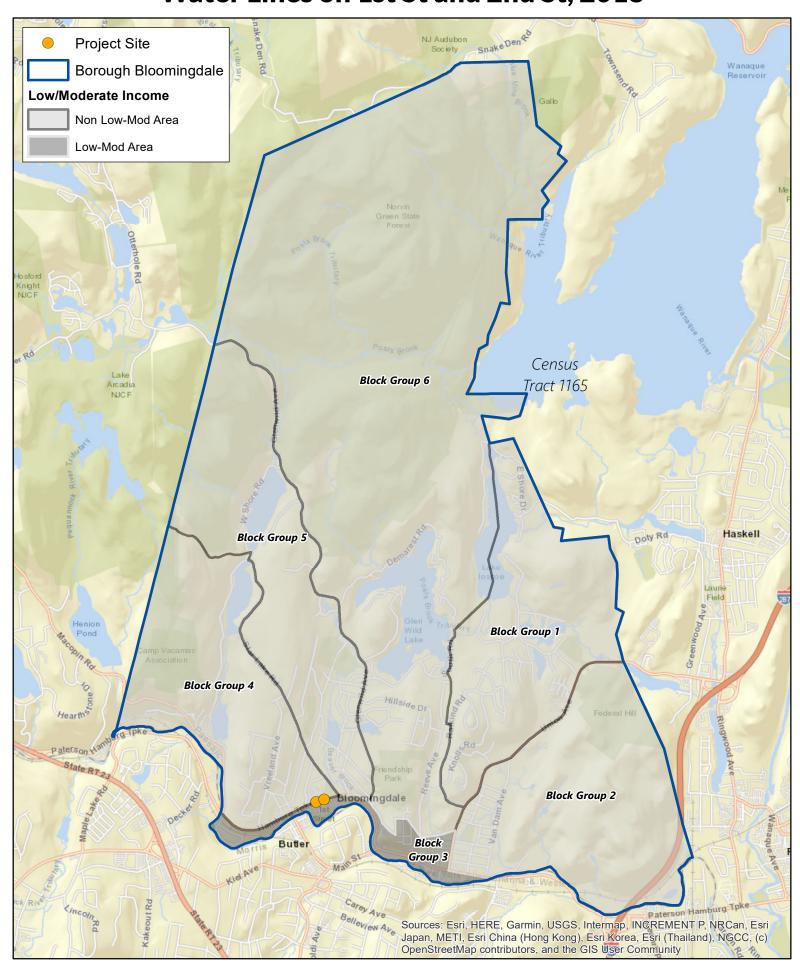
Passaic County, Township of Little Falls Micklejohn Ave - Street Improvements, 2017



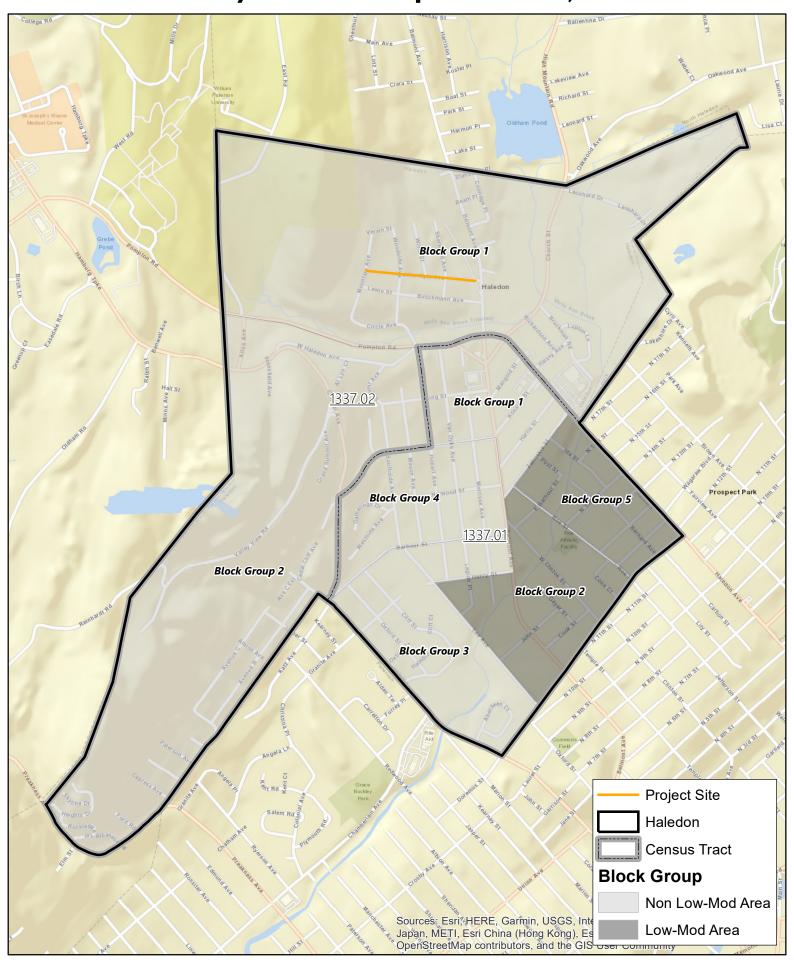
Passaic County, Township of West Milford Handicap Access to Recreation Center, 2017



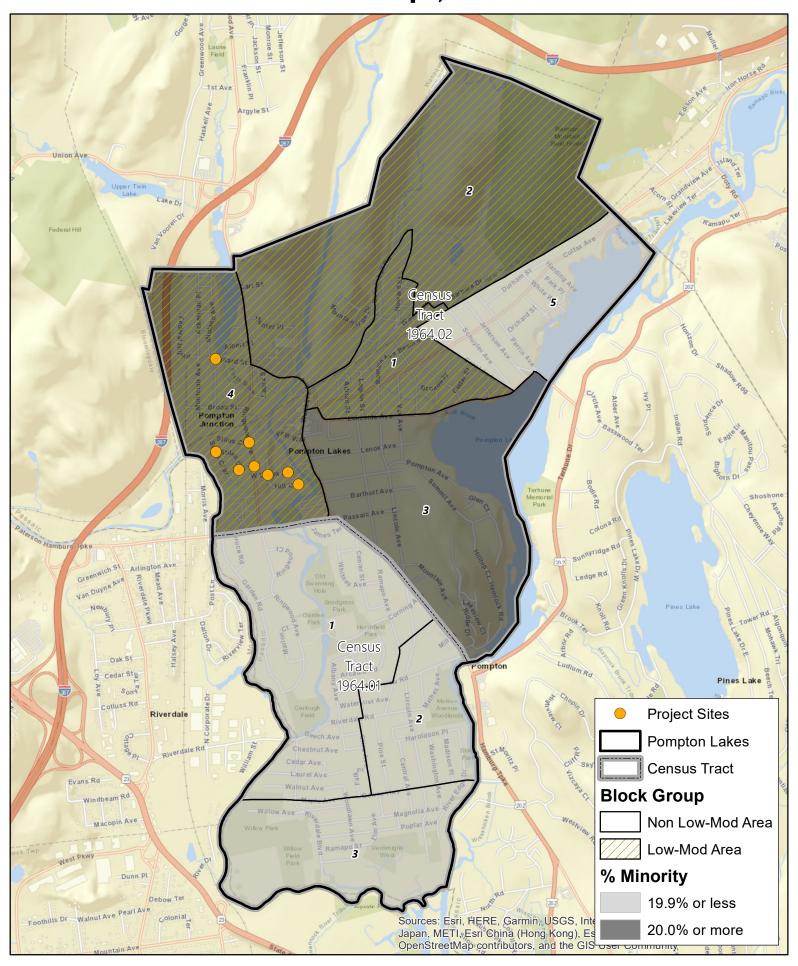
Passaic County, Borough of Bloomingdale Water Lines on 1st St and 2nd St, 2018



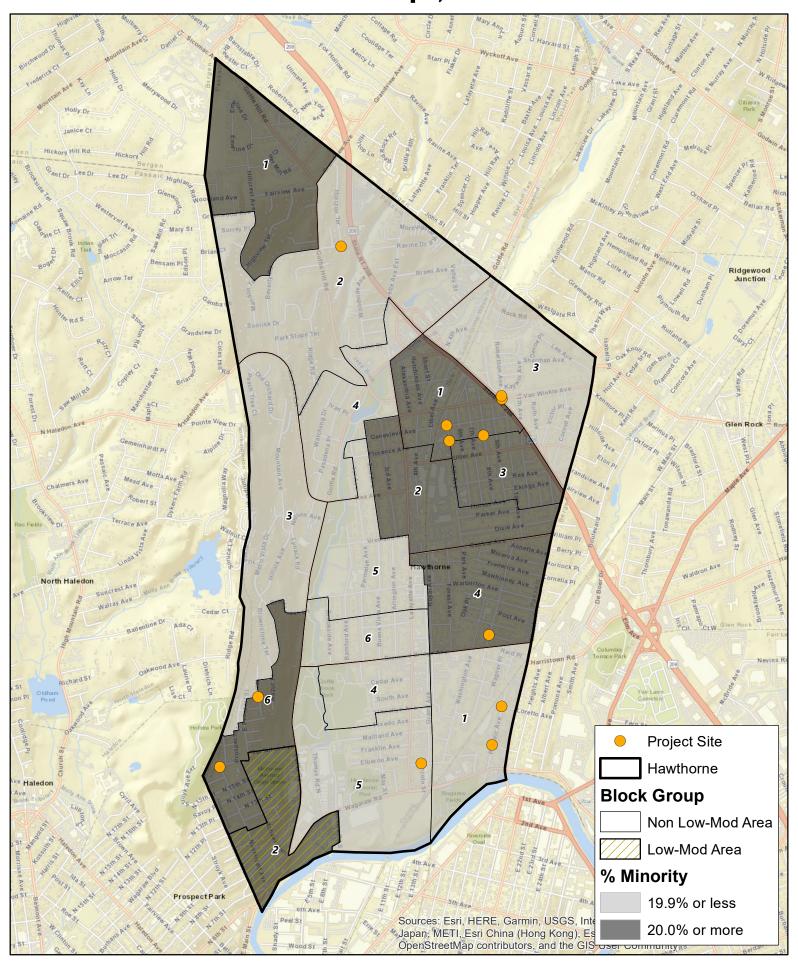
Passaic County, Borough of Haledon John Ryle Avenue Improvements, 2018



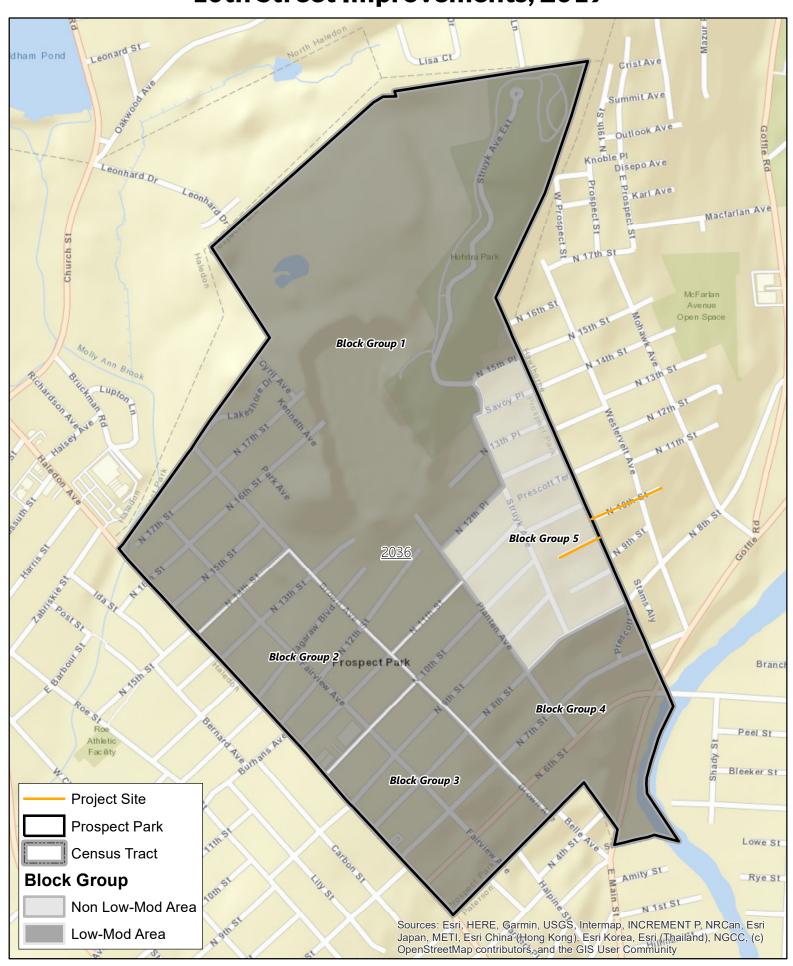
Passaic County, Borough of Pompton Lakes Curb Ramps, 2018



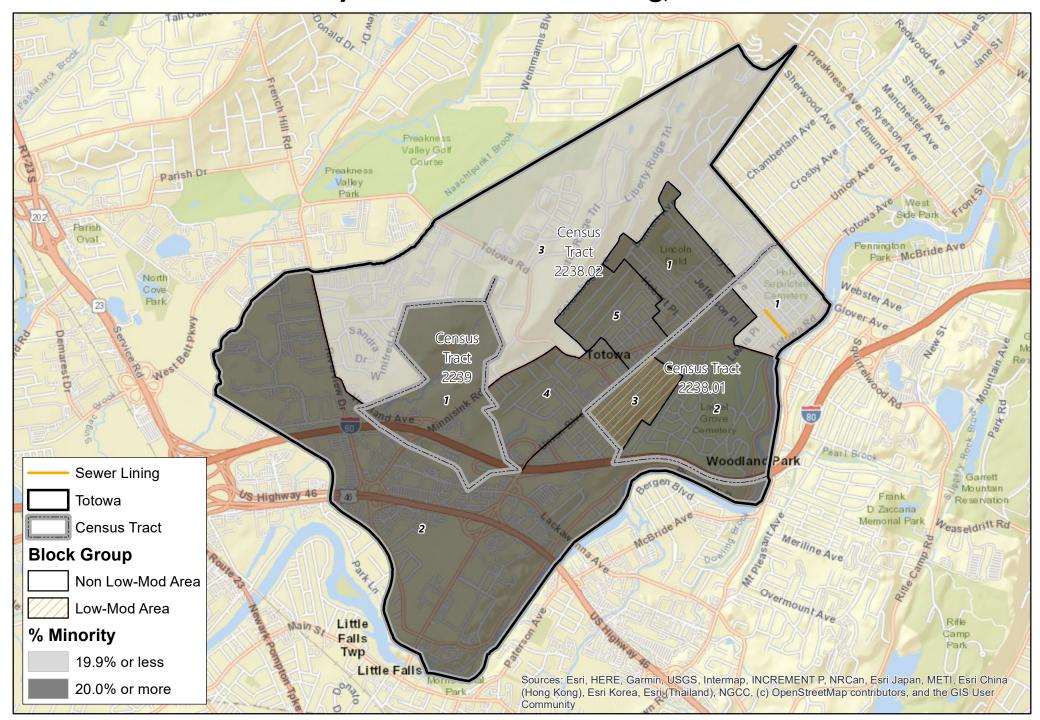
Passaic County, Borough of Hawthorne Curb Ramps, 2019

Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements

Passaic County has adopted a subrecipient monitoring plan. This plan outlines the process for reviewing subrecipient activities throughout the year and for conducting on-site monitoring.

Subrecipient activities were monitored with each request for disbursement. Each request had to provide documentation of every expense and report on the number of beneficiaries served. On-site monitoring was delayed due to Covid but conducted in October 2021 for the FY 2020 funded activities.

Additionally, the public improvements and infrastructure activities were monitored throughout the project. Each subrecipient is expected to research available MBE/WBE and Section 3 firms (as applicable) that might bid on or be interested in subcontracting for their project. These lists are made available to the general contractors who bid the projects as well. A checklist was used to ensure that each compliance requirement was met and that the project stayed on schedule.

The Department of Planning and Economic Development is the lead agency for the Strategic Plan and annual planning activities. Cooperation and support from local municipal governments, and private, non-profit, and for-profit organizations is sought throughout the year and during preparation of the Annual Plans.

The local municipalities and various County departments are consulted for input on community development needs. Applications, over 70, were distributed to all municipalities and non-profits for submission of projects seeking CDBG funding. This process of working with the other county departments and local municipalities will ensure that the program remains very open and participatory.

The CAPER document was placed on public display for a period of 15 days from November 8, 2021 to November 23, 2021.
