**ORDINANCE NO. 27-2022  
OF THE GOVERNING BODY  
OF THE BOROUGH OF BLOOMINGDALE**

**AN ORDINANCE OF THE BOROUGH OF BLOOMINGDALE, IN THE COUNTY OF PASSAIC AND STATE OF NEW JERSEY, AMENDING CHAPTER 92 “ZONING”, ARTICLE IV “SUPPLEMENTARY LOT, HEIGHT AND YARD REGULATIONS”, SECTION 92-14 “YARDS” OF THE CODE OF THE BOROUGH OF BLOOMINGDALE**

**WHEREAS**, the Borough Code currently sets forth zoning standards and restrictions throughout the Borough, including those governing the size of yards; and

**WHEREAS**, the Borough Ordinance Review Committee has reviewed the Code and recommended certain changes be made in order to ensure consistency of treatment and calculation of yard sizes for zoning purposes;

**WHEREAS**, the Borough Council has reviewed and accepted the recommended changes as being in the best interest of the Borough.

**NOW THEREFORE BE IT ORDAINED**, by the Council of the Borough of Bloomingdale, in the County of Passaic, and State of New Jersey, as follows:

**SECTION 1.** Chapter 92 “Zoning”, Article IV “Supplementary Lot, Height and Yard Regulations”, Section 92-14 “Yards” shall be amended to read as follows:

**§92-14 Yards.**

A. Reserved.

All other portions of this Section not addressed herein shall remain unchanged.

**SECTION 2.** All ordinances or parts of ordinances of the Borough of Bloomingdale inconsistent herewith are repealed to the extent of such inconsistency.

**SECTION 3.** If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.

**SECTION 4.** This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.

THE PURCHASE OF A ROCK SALT THROUGH THE PASSAIC COUNTY  
CO-OPERATIVE AS PER BID SB-21-058**

**WHEREAS**, the Governing Body of the Borough of Bloomingdale previously authorized the purchase of rock salt (Reso 2022-1.104) and it has further been determined there is a need for additional rock salt for the upcoming winter season; and

**WHEREAS**, the Borough of Bloomingdale, pursuant to N.J.S.A. 40A:11-11 and N.J.A.C. 5:34-7.3 et seq. may, by Resolution and without advertising for bids, purchase any goods or services through the Passaic County Co-Operative, which has been approved by the Director of the Division of Local Government Services; and

**WHEREAS**, the Borough of Bloomingdale desires to purchase rock salt from the Passaic County Co-Operative as per Bid SB-21-058 : Winter Products, Including Bulk Rock Salt, Grits, Bagged Calcium Chloride, Liquid Calcium Chloride and Bagged Magnesium Chloride; and

**WHEREAS**, Morton Salt of 444 W. Lake Street, Chicago, IL 60606, has been awarded the Contract for Rock Salt at a price of \$66.54 per ton; and

**WHEREAS**, the Superintendent of Public Works and Borough Administration recommend the utilization of this contract on the grounds as the best means available to obtain the rock salt; and

**WHEREAS**, the rock salt shall not exceed the amount of \$25,000.00; and

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Bloomingdale, County of Passaic and State of New Jersey as follows:

1. The Borough of Bloomingdale hereby authorizes the purchase of rock salt from Morton Salt of IL under the Passaic County Co-Operative BID # SB-21-058.

**RESOLUTION AUTHORIZING THE CANCELLATION OF CERTAIN DEPOSITS IN  
THE TANGIBLE PROPERTY TRUST FUND**

**WHEREAS**, the Borough of Bloomingdale maintains a trust fund for found property awaiting disposition known as the Tangible Property Trust Fund; and

**WHEREAS**, the Tangible Property Trust Fund is periodically reviewed by the Police Department for determination of disposition of property; and
