AN ORDINANCE ESTABLISHING A MINIMUM AND MAXIMUM RANGE OF SALARY AND COMPENSATION FOR CATEGORIES AND TITLES OF OFFICERS, NON-CONTRACTUAL EMPLOYEES AND CONTRACTUAL EMPLOYEES OF THE BOROUGH OF BLOOMINGDALE

Purpose: State law requires the adoption of an ordinance establishing a range of salaries for certain Borough positions. The proposed ordinance categorizes positions by department or part/full-time status and thus may reflect a higher maximum salary range for some part-time or non-contractual positions because of other positions comprising the category.

NOW, THEREFORE, BE IT ORDAINED by the Governing Body of the Borough of Bloomingdale, County of Passaic, State of New Jersey, as follows:

Pursuant to the Fair Labor Standards Act, the Borough Clerk, Borough Administrator, Chief Financial Officer, Treasurer, Tax Collector, Construction/Building Official, Superintendent of Public Works, Water/Sewer Superintendent, Police Chief, Municipal Court Administrator and the Animal Control Coordinator shall not be compensated over and above their regular salaries for overtime.

2) LONGEVITY

The only employees who shall receive longevity payments, are those employees afforded the

same through ordinance, a fully ratified collective bargaining agreement, or any other employment agreement or those other employees who are receiving a longevity payment on the date that this ordinance is adopted, subject to the restrictions set forth below.

For all Department Heads hired before January 1, 2014 shall follow the White-Collar Collective Bargaining Agreement that is effective at the time of this Ordinance adoption and will follow all subsequent contracts. No individuals other than those set forth in this Section entitled 2) Longevity, shall be entitled to any longevity payment.

3) SALARIES

Salaries shall be paid semi- monthly on the 15th & the 30th ~~bi weekly~~ with the following exceptions:

- a) Quarterly: Council Members; Public Defender; Fire Official; and Fire Prevention Bureau Secretary.
- b) Hourly employees shall be paid when vouchers are submitted for services rendered.
- c) ~~Upon adequate notice given to the Borough Administrator and the office responsible for processing Borough payroll, full-time employees may receive vacation pay in advance.~~
- 4) None of the provisions contained herein shall be construed as establishing a one-year term of employment. All such officers and employees, other than those elected or appointed pursuant to any statute providing otherwise, shall be subject to removal, except where otherwise provided by applicable statute.
- 5) This Ordinance shall take effect after the final passage and publication as required by law and all other ordinances inconsistent hereby are repealed.

AUTHORIZATION TO RECORD & LIVE STREAM BOROUGH COUNCIL MEETINGS VIA SOCIAL MEDIA PLATFORMS

WHEREAS, the Borough Council seeks to promote transparency and public access to its proceedings through the use of modern technology; and

WHEREAS, live streaming of Council meetings allows members of the public to observe Council discussions remotely; and

WHEREAS, the Council retains authority to establish reasonable rules governing the conduct of its meetings, including whether and how public comment is received; and

WHEREAS, the Council has determined that live streaming meetings without providing for public comment is appropriate to ensure orderly, efficient, and uninterrupted conduct of Council business;

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Bloomingdale, County of Passaic, State of New Jersey as follows:

1. All public portions of the Bloomingdale Council's regular, workshop and special meetings may be live streamed whenever reasonably and technologically possible and posted to the Borough's YouTube channel [or other online social media platform].

A RESOLUTION OF THE BOROUGH OF BLOOMINGDALE, IN THE COUNTY OF PASSAIC AND STATE OF NEW JERSEY, AUTHORIZING THE PURCHASE & DELIVERY OF GASOLINE & DIESEL FUEL UNDER NJ STATE CONTRACT(S), FOR THE DEPARTMENT OF PUBLIC WORKS

WHEREAS, the Bloomingdale Department of Public Works needs to keep a stock of gasoline and diesel fuel for its fleet of vehicles; and

WHEREAS, N.J.S.A. 40A:11-12 of the Local Public Contracts Law authorizes municipalities to use a State Contract and **N.J.A.C. 5:34-7.29** requires Borough Council authorization for contracts exceeding \$53,000.00; and

WHEREAS, Rachles/Michele's Oil Company, 116 Kuller Road, Clifton, New Jersey 07011, is in possession of State Contract 19-FLEET-00973 (T0083 Unleaded Automotive Gasoline) & Contract 19-FOOD-01099 (T1845 Ultra-Low Sulfur Diesel & Biodiesel Fuel); and

WHEREAS, the DPW Superintendent and the Administration of the Borough of Bloomingdale recommends the utilization of these contracts on the grounds as the best means available to obtain gasoline & diesel fuel; and

WHEREAS, the contract to Rachles/Michele's Oil Company shall not exceed the amount of \$150,000.00; and

WHEREAS, the Chief Financial Officer or their designee, has certified the availability of funds as evidenced in the annexed certification; and

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Bloomingdale, in the County of Passaic and State of New Jersey, as follows:

1. The Borough of Bloomingdale hereby authorizes a contract the purchase of gasoline and diesel fuel for its fleet of vehicles from Rachles/Michele's Oil Company of 116 Kuller Road, Clifton, NJ 07011
2. The term of this contract, shall be effective through December 31, 2026.
3. The contract is awarded without public bidding pursuant to N.J.S.A 40A:11-12.
4. The total fee authorized for this contract shall not exceed \$150,000.00, as certified by the Chief Financial Officer, or their designee, without the prior written approval of the Borough Council.
