Call to Order

Ms. Parry Carney called the meeting to order at 7:33 p.m.

Elections of Officers 2022

Board of Health members discussed to possibly change the 2nd quarter meeting in April to the Zoom platform instead of in person due to the rising number of Covid cases. Members discussed to wait to see the trends in Covid cases closer to that time. Discused there is a 2 week timeframe for advertising the change in venue and the Zoom link to the next meeting.

A motion was made by J. Ellis that the 2nd quarter Board of Health meeting will be decided in early March to determine if it will be conducted in person or via Zoom. Mr. Iglesia seconded the motion and all voted in favor.

Ms. Ellis raised the question on ways to recruit new Board of Health members to fill vacant positions. Recruiting via social media was discussed. Ms. Ellis will review with Breanna Calabro, Borough Clerk, suggestions and appropriate measures to advertise and recruit for vacant positions on the Bloomingdale Board of Health.
