**WHEREAS**, on April 2, 2019, the Governing Body of the Borough of Bloomingdale adopted Resolution No. 2019-4.2 authorizing the filing of grant applications with the 2019 Passaic County Open Space, Farmland and Historic Preservation Trust Fund for the Rehabilitation of the Walter T. Bergen Tennis Courts; and

**WHEREAS**, the Borough subsequently received a grant award in the amount of \$99,000.00 from Passaic County for this project; and

**WHEREAS**, Resolution 6-2-1 of the Board of County Commissioners granted a second no-cost extension agreement to the Borough to account for increased costs exceeding the award to allow the Borough to raise the balance needed for additional funding of the proposed project until May 31, 2022; and

**WHEREAS**, on March 3, 2020, the Governing Body of the Borough of Bloomingdale adopted Resolution No. 2020-3.4 authorizing the filing of Grant Applications with the 2020-2021 Passaic County Open Space, Farmland and Historic Preservation Trust Fund for the Rehabilitation of Delazier Field Grandstand & Bathroom Renovations; and

**WHEREAS**, the Borough received a separate grant award in the amount of \$125,000.00 from Passaic County for this project; and

**WHEREAS**, the Borough of Bloomingdale is desirous of repurposing the \$125,000.00 in funding previously allocated for the Rehabilitation of Delazier Field Grandstand & Bathroom Renovations to the Rehabilitation of the Walter T. Bergen Tennis Court; and

**WHEREAS**, the Governing Body has determined it is in the best interest of Bloomingdale and its citizenry to complete the proposed rehabilitation of the Walter T. Bergen Tennis Courts first; and

**WHEREAS**, the Borough of Bloomingdale is requesting that the Board of Commissioners of the County of Passaic approve the request as stated above.

### RESOLUTION NO. 2022-2.18 OF THE GOVERNING BODY OF <u>THE BOROUGH OF BLOOMINGDALE</u> FAIR HOUSING RESOLUTION

The Borough of Bloomingdale supports Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law) and the New Jersey Law Against Discrimination. It is the policy of the Borough of Bloomingdale to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, religion, ancestry, sex (including pregnancy), national origin, nationality, familial status, martial or domestic partnership status, affectional or sexual orientation, atypical hereditary cellular or blood trait, genetic information, liability for military 8 of 12 service, mental or physical disability, perceived disability, AIDS/HIV status and Lawful Income Source of Lawful Rent Payment (Section 8). The Borough of Bloomingdale further objects to discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing, or in the provision of brokerage services because of race, color, religion, ancestry, sex, national origin, handicap or disability as prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law) and the New Jersey Law Against Discrimination. Therefore, the Governing Body of the Borough of Bloomingdale does hereby approve the following resolution:

**BE IT RESOLVED**, that within available resources, the Borough of Bloomingdale will assist all persons who feel they have been discriminated against under one of the aforementioned categories, to seek equity under federal and state laws by filing a complaint with the New Jersey Division on Civil Rights and the U.S. Department of Housing and Urban Development, as appropriate.
