# ORDINANCE NO. 4-2022 OF THE GOVERNING BODY OF THE BOROUGH OF BLOOMINGDALE

# AN ORDINANCE OF THE BOROUGH OF BLOOMINGDALE, IN THE COUNTY OF PASSAIC AND STATE OF NEW JERSEY, AMENDING CHAPTER 92 "ZONING" OF THE CODE OF THE BOROUGH OF BLOOMINGDALE

WHEREAS, the Borough Code currently sets forth zoning standards and restrictions throughout the Borough, including those governing accessory structures; and

**WHEREAS**, the Borough Ordinance Review Committee has reviewed the Code and recommended certain changes be made in order to establish the appropriate use of accessory structures;

**WHEREAS**, the Borough Council has reviewed and accepted the recommended changes as being in the best interest of the Borough.

**NOW THEREFORE BE IT ORDAINED**, by the Council of the Borough of Bloomingdale, in the County of Passaic, and State of New Jersey, as follows:

**SECTION 1.** Chapter 92 "Zoning", Article IV "Supplementary Lot, Height and Yard Regulations", Section 92-17 "Accessory Structures" shall be amended to read as follows:

#### §92-17 Accessory Structures.

#### A. Maximum size regulations.

- (1) The maximum permitted height of accessory structures shall be one and one-half (1 1/2) stories or 15 feet.
  - (2) The maximum permitted total foot print square-footage of all accessory structures on a residential lot shall not exceed the foot print square-footage of the principal dwelling structure.

- B. Minimum yard regulations.
  - (1) Unattached accessory structures in residential districts. Accessory structures which are not attached to a principal structure may be erected within one of the side yards or within the rear yard in accordance with the following setback requirements:
    - (a) Front yard: 50 feet.
    - (b) Side yard (interior lot): five feet.
    - (c) Side yard (corner lot): same as for principal structures.
    - (d) Rear yard: five feet.
    - (e) Accessory structures shall not be closer to a principal structure then 10 feet.
  - (2) Swimming pools. Permanent swimming pools shall be subject to yard requirements covered in Chapter **16**, Swimming Pools, in the Revised General Ordinances of the Borough of Bloomingdale.
  - (3) Attached accessory structures in residential districts. When an accessory structure is attached to the principal building, it shall comply in all aspects to the requirements of this chapter applicable to the principal building.
  - (4) Non-dwelling accessory structures in other districts. Non-dwelling accessory structures shall comply with front and side yard requirements for the principal structure to which they are accessory and shall be not closer to any rear property line than 10 feet; except that where the rear property line shall abut a residential district, the rear yard requirements for the principal structure in that zone district shall apply to all accessory structures.
- C. Accessory structures shall not be utilized as a dwelling structure.
- D. Flag poles in residential districts may be placed in residential yards provided the following setbacks are met:
  - (1) Front Yard: 10 feet.
  - (2) Side yard: 10 feet.
  - (3) Flag poles must be no closer to a principal structure than 10 feet.

All other portions of this Section shall remain unchanged.

**SECTION 2.** Chapter 92 "Zoning", Article XII "Schedule of Regulations", Section 92-44 "R-130 One-Family Residential Zone" shall be amended to read as follows:

#### §92-44 R-130 One-Family Residential Zone.

The following regulations shall apply in the R-130 Zone:

- B. Accessory permitted uses (see §§ 92-16 and 92-17).
  - (1) Home occupations as defined in § 92-26B.
  - (2) Signs as regulated in § 92-26.3G.
  - (3) Private garages and private parking areas (see § 92-22).
  - (4) Private swimming pools [see § 92-17B(2)].
  - (5) Private boathouses on lakefront property at either Glenwild Lake, Lake losco, Kampfe Lake or Morse Lake.
  - (6) Other accessory uses and structures customarily appurtenant to a principal permitted use.

All other portions of this Section shall remain unchanged.

**SECTION 3.** All ordinances or parts of ordinances of the Borough of Bloomingdale inconsistent herewith are repealed to the extent of such inconsistency.

**SECTION 4.** If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.

**SECTION 5.** This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.

**WHEREAS,** for decades, local school districts across New Jersey have been hampered by budgetary constraints in fulfilling their mission of providing the thorough and efficient education guaranteed to every student by the New Jersey State Constitution; and

**WHEREAS,** those budgetary constraints have been exacerbated by the failure of the State of New Jersey to ensure stable, consistent State school aid that enables school districts to address the needs of all students regardless of where they reside and attend school in our state; and

**WHEREAS,** the Bloomingdale School District is one school district whose budgetary constraints have been exacerbated by dramatic reductions in State school aid under the School Funding Reform Act of 2008 ("Act") since 2019, including a projected \$176,019 cut in Governor Murphy's proposed budget for the FY2022-2023 school year:

FY2019-2020: - \$106,413

FY2020-2021: - \$164,443

FY2021-2022: - \$212,542

↓ FY2022-2023: - \$176,019

**WHEREAS,** these State school aid cuts have negatively impacted the Bloomingdale community by forcing Bloomingdale taxpayers to pay higher property taxes for local schools, as evidenced by an analysis by *USA Today Network New Jersey* published on <u>www.northjersey.com</u> on March 8, 2022, showing that Bloomingdale is one of sixty (60) municipalities in New Jersey in which homeowners spend more than 10% of their income on property taxes (\$11,240) if they live in their town's average home (\$255,573) and earn their town's average income (\$112,528); and

WHEREAS, these State school aid cuts have negatively impacted the school district by compromising educational programs and opportunities for Bloomingdale school students; and

**WHEREAS,** S-354 has been introduced with bipartisan support in the New Jersey State Senate to establish the School Funding Formula Evaluation Task Force ("Task Force") for the purpose of studying, evaluating, and assessing the provision of State school aid pursuant to the Act to provide recommendations on improving various aspects of the Act, including:

- The manner in which school district adequacy budgets and local shares are calculated;
- The current methodology of measuring and weighting at-risk students and students with limited English proficiency and the impact on the educational outcomes of those students;
- The weights applied to students in different grade levels, as well as those applied to students enrolled in county vocational school districts;
- The current methodology used to calculate the geographic cost adjustment;
- The formula's use of the census-based funding methodology for determining the amount of State aid a school district receives to educate its special education population and the effects of potentially employing different methodologies;
- The provision of extraordinary special education aid and the cost thresholds used as the bases for reimbursement of extraordinary special education costs;
- The methodologies used to calculate security categorical aid and transportation aid;
   and
- The impact that the reallocation of State school aid pursuant to P.L.2018, c.67, commonly referred to as "S-2," had on 43 school districts' finances; and

**WHEREAS,** S-354 directs the Task Force to issue a final report detailing its findings and recommendations to the Governor of the State of New Jersey and the New Jersey State Legislature no later than one year after its organization; and

**WHEREAS,** the Bloomingdale Borough Council, in conjunction with the Bloomingdale Board of Education, welcomes the renewed focus and transparency that S-354 is intended to bring to the provision of State school aid pursuant to the Act in the hope that it will achieve more stable and consistent State school aid for local school districts that will ameliorate local property taxes, while expanding educational programs and opportunities for all students; and
