Mayor D'Amato stated: This Meeting is called pursuant to the provisions of the Open Public Meetings Law. A copy of this notice is available to the public and is on file in the office of the Municipal Clerk.

A. Second/Final Reading & Public Hearing:

Bond Ordinance No. 21-2022: Special Assessment (Hilltop Terrace Sidewalks)

The Municipal Clerk, Breeanna Smith, read the Public Notice statement.

Councilwoman Hudson moved that the Ordinance be read by title; seconded by GRAZIANO and carried on voice vote – all members present voting AYE

The Municipal Clerk read the following Ordinance by title:

BOROUGH OF BLOOMINGDALE BOND ORDINANCE NO. 21-2022

BOND ORDINANCE PROVIDING FOR SIDEWALK IMPROVEMENTS ALONG THE ENTIRE LENGTH OF HILLTOP TERRACE, IN AND BY THE BOROUGH OF BLOOMINGDALE, IN THE COUNTY OF PASSAIC, STATE OF NEW JERSEY; APPROPRIATING \$275,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$261,000 BONDS OR NOTES OF

THE BOROUGH TO FINANCE PART OF THE COST THEREOF AND THE SPECIAL ASSESSMENT OF THE COST THEREOF

BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF BLOOMINGDALE, IN THE COUNTY OF PASSAIC, STATE OF NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

SECTION 1. The improvements or purposes described in Section 3 of this bond ordinance are hereby authorized as a local improvements to be undertaken by the Borough of Bloomingdale, in the County of Passaic, State of New Jersey (the "Borough"), pursuant to N.J.S.A. 40:56-1 et seq. and N.J.S.A. 40:65-1 et seq., and the costs of said improvements shall be assessed on those properties specially benefitted thereby. For the improvements or purposes stated in Section 3 hereof, there is hereby appropriated the amount of \$275,000, including the amount of \$14,000 as the down payment for the improvements or purposes required by the Local Bond Law, N.J.S.A. 40A:2-1 et seq. (the "Local Bond Law"). The aforementioned down payment is now available therefor by virtue of a provision or provisions in a previously adopted budget or budgets of the Borough for down payment or for capital improvement purposes.

SECTION 2. For the financing of said improvements or purposes and to meet the part of the \$275,000 appropriation not provided for by application hereunder of the down payment, negotiable bonds of the Borough are hereby authorized to be issued in the principal amount of \$261,000 pursuant to, and within the limitations prescribed by, the Local Bond Law. In anticipation of the issuance of said bonds and to temporarily finance said improvements or purposes, negotiable notes of the Borough in a principal amount not exceeding \$261,000 are hereby authorized to be issued pursuant to, and within the limitations prescribed by, the Local Bond Law.

SECTION 3. (a) The improvements hereby authorized and purposes for the financing of which said obligations are to be issued are for sidewalk improvements along the entire length of Hilltop Terrace, including, but not limited to, the construction, reconstruction and/or repair of sidewalks, curbs, driveway aprons and other similar construction along various real properties identified and described in **Schedule A** attached hereto and by this reference hereby incorporated herein, which properties are owned by private persons. The improvements and purposes provided for herein shall also include, but not be limited to, site excavation and restoration, tree and root removal, grass seeding, tree planting and other landscaping improvements, incidental roadway repaving and patching, all engineering and design work, preparation of plans and specifications, permits, bid documents, contract administration, work, materials, equipment, labor and appurtenances as necessary therefor or incidental thereto.

- (b) The estimated maximum amount of bonds or notes to be issued for the improvements or purposes herein is \$261,000.
- (c) The estimated total cost of said improvements or purposes is equal to \$275,000, the amount of the appropriation herein made therefor.

(d) The properties to be specially benefited by these improvements are the properties identified in **Schedule A** attached hereto and by this reference hereby incorporated herein (collectively, the "Assessed Properties"), which Assessed Properties are also on file in the office of the Borough Clerk and are hereby incorporated in this bond ordinance as if more fully set forth herein.

(e) The estimated total cost of the improvements or purposes to be assessed against the Assessed Properties is \$275,000.

(f) The estimated total cost of the improvements or purposes to be contributed and borne by the Borough is \$0.

SECTION 4. In the event the United States of America, the State of New Jersey, and/or the County of Passaic make a contribution or grant in aid to the Borough for the improvements and purposes authorized hereby and the same shall be received by the Borough prior to the issuance of the bonds or notes authorized in Section 2 hereof, then the amount of such bonds or notes to be issued shall be reduced by the amount so received. In the event, however, that any amount so contributed or granted shall be received by the Borough after the issuance of the bonds or notes authorized in Section 2 hereof, then such funds shall be applied to the payment of the bonds or notes so issued and shall be used for no other purpose.

SECTION 5. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer or the Treasurer of the Borough, provided that no note shall mature later than one (1) year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer or the Treasurer. The Chief Financial Officer or the Treasurer of the Borough shall determine all matters in connection with the notes issued pursuant to this bond ordinance, and the signature of the Chief Financial Officer or the Treasurer upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time in accordance with the provisions of the Local Bond Law. The Chief Financial Officer or the Treasurer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchaser thereof upon receipt of payment of the purchase price and accrued interest thereon from their dates to the date of delivery thereof. The Chief Financial Officer or the Treasurer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this bond ordinance is made. Such report must include the principal amount, the description, the interest rate, and the maturity schedule of the notes so sold, the price obtained and the name of the purchaser.

SECTION 6. The capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency, a resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs (the "Director of the Division of Local Government Services") will be on file in the office of the Clerk and will be available for public inspection.

SECTION 7. The following additional matters are hereby determined, declared, recited and

stated:

(a) The improvements and purposes described in Section 3 of this bond ordinance shall be undertaken as local improvements and are not current expenses and are improvements which the Borough may lawfully undertake as local improvements, the costs of which have been or shall be specially assessed on the Assessed Properties, which Assessed Properties shall be specially benefited thereby. An accurate account of the cost of the construction, reconstruction or repair of the sidewalks, curbs, driveway aprons and other similar construction shall be undertaken by the Borough, and such cost shall be assessed upon the several properties fronting the improvements in proportion to their respective frontage thereon pursuant to and in accordance with N.J.S.A. 40:65-1 et seq.

- (b) The Borough will contribute \$0 to the cost of the improvements or purposes described in Section 3 hereof, and the Assessed Properties will contribute \$275,000 to the cost of the improvements or purposes described in Section 3 hereof.
- (c) The number of annual installments in which the special assessments may be paid is ten(10) years.
 - (d) The estimated maximum amount of special assessments shall be \$275,000.
- (e) At least ten (10) days prior to such time fixed for public hearing and further consideration for final passage of this bond ordinance, a copy of this bond ordinance, together with a notice of the pendency of this bond ordinance, may be given to the owners of the real estate affected hereby in accordance with N.J.S.A. 40:65-6, and such notice shall contain the time and place, when and where this bond ordinance will be further considered for final passage, in accordance with the provisions of N.J.S.A. 40:65-2 to N.J.S.A. 40:65-6, and such notice must be provided to every person interested in the proposed improvement and whose lands may be affected by this bond ordinance or any assessments which may be made in pursuance hereof. If the above-described notice of the pendency of this bond ordinance is not given in accordance with N.J.S.A. 40:65-6 to the owners of property affected hereby and a hearing is not given to all persons interested in the improvements at the time and place stated in the notice, the Borough Clerk shall cause a notice of the proposed sidewalk, curb, driveway apron and other similar construction improvements to be given to the owner or owners of real estate affected hereby prior to the making of the sidewalk improvements described in Section 3 hereof or the awarding of any contract for such improvements. The Notice shall contain a description of the property affected sufficient to identify it, a description of the improvements, and a statement of the percentage of the cost to be borne by the owner or owners of such real estate, if the cost thereof is to be borne in part by such owners, or a statement that unless the owner or owners complete the improvements within thirty (30) days after service thereof, the Borough will make the improvements at the expense of the owner or owners, if the cost of the improvements is to be borne wholly by the owner or owners of the real estate. Such Notice shall be served in accordance with the provisions of N.J.S.A. 40:65-2 to N.J.S.A. 40:65-6, and the proof of service shall be filed with the officer of the Borough in charge of the records of tax liens of the Borough within ten (10) days after

service thereof, but failure to file such proofs shall not invalidate the proceedings if service has been made as hereinbefore provided.

- (f) The period of usefulness of the improvements or purposes within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this bond ordinance, is ten (10) years.
- (g) The supplemental debt statement required by the Local Bond Law has been duly made and filed in the Office of the Clerk of the Borough and a complete executed duplicate thereof has been filed in the Office of the Director of the Division of Local Government Services, and such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds or notes provided for in this bond ordinance by \$261,000 and the obligations authorized by this bond ordinance will be within all debt limitations prescribed by said Local Bond Law.
- (h) An aggregate amount not exceeding \$10,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purposes or improvements described herein
- (i) If the amount of the assessments on the Assessed Properties is less than \$275,000, then the Borough will contribute the difference between such reduced assessment and the cost of the improvements.

SECTION 8. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy ad valorem taxes upon all the taxable property within the Borough for the payment of the obligations and the interest thereon without limitation as to rate or amount.

SECTION 9. The Borough reasonably expects to reimburse any expenditures toward the costs of the improvements or purposes described in Section 3 hereof and paid prior to the issuance of any bonds or notes authorized by this bond ordinance with the proceeds of such bonds or notes. This Section 9 is intended to be and hereby is a declaration of the Borough's official intent to reimburse any expenditures toward the costs of the improvements or purposes described in Section 3 hereof to be incurred and paid prior to the issuance of bonds or notes authorized herein in accordance with Treasury Regulations Section 150-2. All reimbursement allocations will occur not later than eighteen (18) months after the later of (i) the date the expenditure from a source other than any bonds or notes authorized herein is paid, or (ii) the date the improvements or purposes described in Section 3 hereof are "placed in service" (within the meaning of Treasury Regulations §1.150-2) or abandoned, but in no event more than three (3) years after the expenditure is paid.

SECTION 10. The Borough covenants to maintain the exclusion from gross income under section 103(a) of the Internal Revenue Code of 1986, as amended, of the interest on all tax-exempt bonds and notes issued under this ordinance.

SECTION 11. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption, as provided by the Local Bond Law.

AN ORDINANCE OF THE BOROUGH OF BLOOMINGDALE, COUNTY OF PASSAIC, STATE OF NEW JERSEY AUTHORIZING AND CONFIRMING THE SPECIAL ASSESSMENTS CALCULATED PURSUANT TO STATUTE AND SET FORTH IN THE REPORT OF DARMOFALSKI ENGINEERING ASSOCIATES, INC. IN CONNECTION WITH THE HAMILTON STREET SIDEWALK IMPROVEMENTS TO BE PAID IN INSTALLMENTS OVER THE COURSE OF TEN (10) YEARS

WHEREAS, the Borough Council adopted Bond Ordinance 6-2021 which authorized the issuance of bonds or notes to finance portions of the Hamilton Street Improvement Project not paid for through grants and authorized institution of a special assessment for recovery of that portion of the project which benefitted residents' property; and

WHEREAS, upon completion of the project and calculation of the assessment for each property owner, Darmofalski Engineering Associates, Inc. issued a final report setting forth such assessments; and

WHEREAS, after due notices were given, a public hearing was held on August 16, 2022 pursuant to N.J.S.A. §40:56-25 and

WHEREAS, the Borough Council has considered the assessment report submitted by Darmofalski Engineering Associates, Inc. in connection with the assessment of benefit conferred upon lots and parcels of land by reason of the installation of sidewalks on Hamilton Street as part of the Hamilton Street Improvement Project in accordance with Bond Ordinance No. 6-2021 adopted on March 2, 2021; and

WHEREAS, the Borough Council finds that the appropriate notice has been given to the benefitted property owners pursuant to N.J.S.A. §40:56-25 and N.J.S.A. §40:56-30 and that the report is in proper form.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Bloomingdale, in the County of Passaic, State of New Jersey as follows:

1. The cost of the sidewalk improvements shall be assessed against all benefitting properties as listed in the Darmofalski Engineering Associates, Inc. report attached hereto as Exhibit A as of June 23, 2022.

- 2. The special assessments assigned to the Hamilton Street property owners as set forth in Exhibit A are hereby adopted and confirmed.
- 3. The procedures for making and collecting this special assessment, which are set forth in N.J.S.A. §40:56-1 *et seq.* and N.J.S.A. §40:65-1 *et seq.*, have been followed in developing the information contained in Exhibit A.
- Pursuant to N.J.S.A. §40:56-33, the special assessment shall be a lien on the property paramount to all prior or subsequent alienations and descents of such real estate or encumbrances thereon. A record of this paramount lien shall be maintained in accordance with N.J.S.A. §40:56-41.3.
- 5. Each Hamilton Street property owner may make a lump sum payment of the full assessment amount within sixty (60) days of the effective date of adoption of this Ordinance which sets the special assessment, or at any time thereafter, or may pay said amount in installment payments to be made over a period of ten (10) years in accordance with the notices to be provided by the Borough Tax Collector pursuant to N.J.S.A. §40:56-35.
- 6. Bills for the special assessment will be sent out by the Borough Tax Collector annually.
- 7. If any payment is not made, except for good cause, the Borough has the right to demand payment of the entire assessment, less amounts already remitted, in full be made within fifteen (15) days of the date of demand. If full payment is not made, the Borough may pursue all legal options, including filing a lien against the property or forcing sale of the property.
- 8. Pursuant to N.J.S.A. §40:56-35, the governing body may permit any person who is delinquent in the payment of such an installment to pay only the amount of the delinquent payment and any interest on the delinquent payment that has accrued from the date that the installment was due and payable until the date that payment of the delinquent installment is made. After the delinquent installment is satisfied, the person assessed shall be reinstated on a regular installment payment schedule. This accommodation shall be permitted to a property owner only once throughout the course of the ten (10) years of repayment.
- 9. The Borough Tax Collector shall be provided with a copy of this Ordinance and is hereby directed to proceed with the collection of the assessments herein.
- 10. All ordinances or parts of ordinances of the Borough of Bloomingdale inconsistent herewith are repealed to the extent of such inconsistency.
- 11. If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any court or competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.

AN ORDINANCE OF THE BOROUGH OF BLOOMINGDALE, IN THE COUNTY OF PASSAIC AND STATE OF NEW JERSEY, AMENDING CHAPTER 2 "ADMINISTRATION", ARTICLE V "DEPARTMENTS ESTABLISHED" TO ADD SECTION 2-43 "SPECIAL LAW ENFORCEMENT OFFICER CLASS III" TO THE CODE OF THE BOROUGH OF BLOOMINGDALE

WHEREAS, the Bloomingdale Board of Education and the Borough Council desire to protect the Borough's public schools; and

WHEREAS, New Jersey's former Governor, Chris Christie, signed Bill S86/A3629 establishing Special Law Enforcement Officer Class III, which would be uniformed, armed, retired police officers; and who, when on school property during times when students and staff are present and/or anytime they are going to and from the school, would have the same authority to take police action as a law enforcement officer; and

WHEREAS N.J.S.A. 40A:14-146.10 permits a local unit to appoint special law enforcement officers to perform the duties and responsibilities permitted by local ordinances authorized by N.J.S.A. 40A:14-118 and N.J.S.A. 40A:14-106; and

WHEREAS, the Borough Administration recommends the Borough Council establish the position of Special Law Enforcement Officer Class III for the purpose of protecting the Borough of Bloomingdale's public schools.

NOW THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Bloomingdale in the County of Passaic and State of New Jersey, as follows:

SECTION 1.. Chapter 2 "Administration", Article V "Departments Established" is hereby amended to add a new Section 2-43 "Special Law Enforcement Officer Class III" to read as follows:

§ 2-43 SPECIAL LAW ENFORCEMENT OFFICER CLASS III

§2-43.1 RESPONSIBILITIES AND DUTIES.

A. Class III special law enforcement officers shall be responsible for providing armed security at all public schools and facilities within the Borough and/or at official school functions attended by students outside of school facilities, as may be directed by the Chief of Police, or his or her designee, subject to the provisions of N.J.S.A. 40A:14-146.11.

B. When on duty, all Class III special law enforcement officers shall exercise the full powers and duties, including the carrying and use of a firearm and other mechanical force devices as prescribed by the Chief of Police, as sworn police officers of the Borough of Bloomingdale Police Department. Class III special law enforcement officers are authorized to respond to offenses and emergencies off school property if they occur in their presence.

- C. In times of disaster and/or emergency, the Chief of Police, or his or her designee, may activate, recall and/or otherwise assign any Class III special law enforcement officer to any duty in support of the operations of the Bloomingdale Police Department's response to said disaster and/or emergency.
- D. Class III special law enforcement officers shall be issued a firearm, mechanical force devices and any such other equipment or supplies necessary to perform their duties as determined by the Chief of Police, who shall also prescribe uniforms that the special officers are responsible for acquiring. Class III special law enforcement officers shall be responsible for the care and maintenance of their uniforms and equipment and shall wear the uniform of the day and carry a firearm and other mechanical force devices and equipment as prescribed by the Chief of Police at all times when on duty.

§2-43.2 QUALIFICATIONS.

- A. All Class III special law enforcement officers shall meet the qualifications set forth in N.J.S.A. 40A:14-146.10. In addition to the qualifications required by N.J.S.A. 40A:14-146.10, all Class III special law enforcement officers shall:
 - 1. Be a citizen of the United States.
 - 2. Be currently living in New Jersey and possess a valid New Jersey Driver's License.
 - 3. Be a retired police officer who has previously served as a duly qualified, full time law enforcement officer in any municipality, county, agency of this state, bi-state agency, or federal agency. [break in service must not exceed three (3) years]
 - 4. Be retired from that agency in good standing.
 - 5. Be less than 65 years of age for the appointment.
 - 6. Pass a psychological exam, a medical exam, and a drug screening pursuant to the Attorney General's Law Enforcement Drug Testing Policy.
 - 7. Successfully pass a background investigation to be conducted by the Bloomingdale Police Department.
 - 8. Successfully complete School Resource Officer training within 12 months of appointment.

§2-43.3 APPOINTMENT PROCESS

- A. All qualified persons desiring to be appointed as Class III special law enforcement officers shall apply as prescribed by the Chief of Police and/or his or her designee.
- B. All applicants will be subject to a background check, a motor vehicle driving record check and medical, physical, psychological, and/or drug screening examinations.
- C. All applicants will be evaluated based upon their resume, qualifications, education, service record and interviews with, and recommendations of, the Chief of Police

and the Borough Administrator, as well as any other Borough officials involved in the evaluation and hiring process.

- D. The Chief of Police and the Borough Administrator shall recommend the most qualified applicant(s) to the Mayor and Council for appointment.
- E. After appointment by the Mayor and Council, all appointees shall swear or affirm an oath of office as a Class III special law enforcement officer of the Borough of Bloomingdale, shall be issued a badge and identification and shall report as ordered to the Chief of Police for training and deployment.
- F. The his shall be a part-time appointment for a term of one year from the date of appointment.
- G. Appointees who fail to successfully complete any training, continuing education, or weapons qualification, as mandated by state statute, the rules and regulations of the Bloomingdale Police Department or the Chief of Police, shall be immediately terminated.

§2-43.5. PERSONNEL POLICIES.

- A. The terms of employment for all Class III special law enforcement officers shall be governed by the provisions of this Chapter, the Borough of Bloomingdale Employee Personnel Policy Handbook and any other such ordinances or resolutions as may be adopted by the Mayor and Council.
- B. Notwithstanding any other provisions to the contrary, Class III special law enforcement officers shall not be eligible, as a result of their employment as a special law enforcement officer, for the following benefits:
 - 1. Health, dental or prescription benefits.
 - 2. Enrollment in any state pension system.
 - 3. Paid vacation leave.
 - 4. Unemployment compensation.
 - 5. Any severance, terminal leave, retirement or separation benefits.
- C. The salary and wages of all Class III special law enforcement officers shall be established pursuant to the Salary Ordinance adopted by the Mayor and Council. Wages will be paid only for hours worked, including hours attending mandated training, continuing education and weapon qualification, unless otherwise specified in this chapter.
- D. During each term of appointment, Class III special law enforcement officers shall be permitted to take paid time off under the Paid Sick Leave Act.
- E. Class III special law enforcement officers shall be available for work on all official school days in the academic calendar when faculty is working in the school buildings. The work schedule and post for all Class III special law enforcement officers shall be established by the Chief of Police or his or her designee.
- F. Any and all policies and rules governing the hiring, employment, performance, conduct, deployment, scheduling, and/or duties of Class III special law enforcement officers, not otherwise provided for in this chapter, shall be governed by the Borough of Bloomingdale Employee Personnel Policy Handbook, the Salary Ordinance, the rules and regulations of the Bloomingdale Police Department and the policies and decisions of the Chief of Police and the Borough Administrator.

D. <u>DISCUSSION</u>: Establishing a 'Building Design Review Board' for the Bloomingdale Center District zone (BCD)

Background of discussion: The Ordinance Review committee has requested the Mayor and council establish this board by ordinance including membership categories, authority and responsibility. The 'BDRB would be advisory to the Building Department, Zoning Officer and Planning Board. The goal of the board would be to ensure that new construction and exterior alterations of any kind to existing buildings are compatible with the existing or desired target character of the area as described in the Borough Code.

Council discussed and unanimously agreed to support the establishment of a 'Building Design Review Board'. The Board will have a beneficial role in guiding BCD development in conjunction with strict standard enforcement. The Board will not be rule making & will only be advisory and provide guidance on the façade / look of future design and alterations. The Board will be able to carry out the intent of creating the 'Business Center District' zone. Mr. Sondermeyer will inform the Ordinance Review of the Council's support so they can begin to develop an ordinance for the Borough Attorney's review and input.
