“Regulation of Electronic Smoke Devices and Psychoactive Products

A motion was made by J. Reynolds to introduce the Ordinance by title; second and final reading/ public hearing will be on September 8, 2025, at 7:30PM; the motion was seconded by M. Catalano and carried on the following voice vote: all members present voting AYE, in favor; none were opposed.

**AN ORDINANCE OF THE BOARD OF HEALTH OF THE BOROUGH OF BLOOMINGDALE, IN THE COUNTY OF PASSAIC AND STATE OF NEW JERSEY, AMENDING THE BOARD OF HEALTH CODE OF THE BOROUGH OF BLOOMINGDALE TO ADD A NEW CHAPTER BH12 “REGULATION OF ELECTRONIC SMOKE DEVICES AND PSYCHOACTIVE PRODUCTS”**

Board discussed and raised questions on the Ordinance. Board will look into how existing businesses will be informed of the new ordinance.
